## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of Issaquah School District No. 411 from September 1, 2016 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance program – health and welfare (vision)
- Tracking and safeguarding of theft-sensitive items, with a focus on technology equipment
- Compliance with debt limitation and new bond issuance
- Student Store activities – cash receipting and inventory at Skyline High School
- Associated Student Body activities – cash receipting and fundraising at Issaquah and Liberty High Schools
- Associated Student Body – expenditure transaction testing and review of student council meeting minutes
- Basic enrollment reporting at Skyline High School

## INFORMATION ABOUT THE DISTRICT

Issaquah School District No. 411 serves approximately 20,000 students in kindergarten through 12th grade in the foothills of the Cascade Mountains. The District operates three comprehensive high schools, one innovative public high school, five middle schools and 15 elementary schools. It also operates the educational section at the state's Echo Glen Children's Center in Snoqualmie.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 2,400 employees. For fiscal year 2017, the District operated on an annual budget of approximately \$235 million.
