Purpose of ARP/ESSER-III Funds

• "...[provide] states and school districts help to safely reopen and sustain the the safe operation of schools and address the impact of the COVID-19 pandemic on the nation's students."

ESSER III Allowable Expenses

- Regular Allowable Expenses through Titles I-IV, IDEA
- May be used for pre-award expenses up to March 2020
- Receipts for payment available through September 2023
 - Last amendment by September 30, 2022
- At least 20% must be used to target learning loss
 - Summer Learning
 - Evidence-based intervention strategies
 - After-school programs
 - Extended-school year
 - Address the disproportionate impact of COVID-19 on underrepresented student subgroups
- Must ensure that interventions meet students' academic and social-emotional needs
- Can implement public health strategies as required by CDC/local public health agency





ESSER III Application Requirements

- Seek stakeholder input for the use of 20%
- Post Safe Return to Learning Plan on District Website
 - Allow for public commentary and feedback
 - Presented at June 16, 2021 BoE Meeting
 - Feedback taken into consideration in July, August, and continues today
- Explain how LEA will assure continuity of services
- Review and post to the website amended plan every 6 months
- Explain how ARP ESSER Funds will be used to follow CDC/IDPH guidelines



State-Level Reservations

- States required to determine three State-level reservations (~5% of allocation) for evidence-based activities and interventions
 - Learning Loss (5%)
 - **\$104,670**
 - Summer Enrichment (1%)
 - \$20,934
 - After-School Program (1%)
 - \$20,934
 - Total of required setaside
 - \$146,538
