4. Renewal of District of Innovation Designation

Dr. Faulkner/Dr. Pitts

Dr. Pitts explained what a District of Innovation Plan was and how it could be implemented to serve public schools districts similar to open enrollment charter schools. He explained that the 5-year term of the current DOI was about to expire and that CSISD would need the CAT team to address the plan and make recommendations to renew for the next 5 years. Dr. Pitts provided each committee member a copy of the 2017-2022 CSISD DOI Plan to view as he explained what areas CSISD addressed in the initial adoption of the plan. After discussing, Dr. Pitts asked committee members for their input regarding areas they felt might need to be addressed. Committees members stated that they felt the DOI was adequate to properly serve the students/staff of CSISD and made the recommendation to move forward with renewal of the CSISD DOI Plan. Dr. Pitts then informed the CAT Team that he would have a revised Final DOI Plan proposal ready for the next CAT Team meeting on October 27, 2021.
