## **BOARD RESOLUTION NO. 11-17 Quincy School District No. 144 Grant County, Washington**

### **A BOARD RESOLUTION AUTHORIZING THE REGISTRATION OF QUINCY SCHOOL DISTRICT AS A PARTICIPATING PUBLIC AGENCY FOR COOPERATIVE PURCHASING THROUGH PEPPM/CENTRAL SUSQUEHANNA INTERMEDIATE UNIT**

**WHEREAS**, pursuant to the provisions of RCW 28A.335.190 of the Revised Code of Washington, Quincy School District must solicit quotations for the purchase and lease of furniture, equipment and supplies between \$40,000 to \$74,999 and any purchase and lease of furniture, equipment and supplies over \$75,000 must be competitively bid; and

**WHEREAS**, pursuant to RCW 39.34, Quincy School District may enter into interlocal cooperative purchasing agreements with other public agencies in order to allow the parties to said agreement to cooperatively purchase or acquire furniture, equipment and supplies under contracts and to utilize each other's contracts, as needs arise; and

**WHEREAS**, PEPPM/Central Susquehanna Intermediate Unit is a public purchasing cooperative that assists public agencies in reducing the cost of purchased goods through pooling the purchasing power of public agencies nationwide; this is accomplished through competitively solicited contracts for quality products through members of PEPPM/Central Susquehanna Intermediate Unit, and who allow participating public agencies to purchase furniture, equipment and supplies from the competitively solicited contracts on the terms and conditions set forth in contracts; and

**WHEREAS**, Business Manager has recommended to the Board of Directors that Quincy School District register as a participating public agency with PEPPM/Central Susquehanna Intermediate Unit under the terms and conditions set forth in the attached Interlocal Cooperative Purchasing Agreement, which is incorporated herein by this reference; and


**WHEREAS**, Business Manager has recommended that she be authorized to take such actions as are necessary to register Quincy School District as a participating public agency with PEPPM/Central Susquehanna Intermediate Unit.


**NOW, THEREFORE BE IT RESOLVED** by the Board of Directors of Quincy School District as follows:




1. Quincy School District shall register as a participating agency with PEPPM/Central Susquehanna Intermediate Unit under the terms and conditions set forth in the attached Master Intergovernmental Cooperative Purchasing Agreement; and
2. The Business Manager is authorized to take such actions as are necessary to register Quincy School District as a participating public agency with Region VIII Education Service Center Interlocal Cooperative Purchasing Agreement for the purposes as cited under RCW 39.34.
