PSESD PEOPLE, LAND AND WATER ACKNOWLEDGMENT LAND AND WATER ACKNOWLEDGMENT

Puget Sound ESD (PSESD) recognizes the way to true reconciliation starts with facing and accepting our past, which is rooted in colonization, imperialism, and white supremacy, and authentically moving towards honoring Indigenous people and land we occupy. PSESD acknowledges the region we support and occupy are the ancestral territories of the Coast Salish people. As the original stewards of the land, the Coast Salish people are comprised of tribes that spanned across the Pacific Northwest Coast of Turtle Island.

PSESD recognizes there are 29 federally recognized tribes in the state of Washington and five tribes in the state that are not recognized by the U.S. federal government but are recognized by the state. Our region of service includes the tribes of Duwamish, Muckleshoot, Nisqually, Puyallup, Skokomish, Snoqualmie, Stillaguamish, Steilacoom, and Suquamish.

PSESD physical spaces reside on the traditional lands of the Duwamish Tribe, Muckleshoot Indian Tribe, and Puyallup Tribe, who historically lived throughout the Black, Cedar, Green, Puyallup, and White River Watersheds. The PSESD Renton Office sits on the ancestral Duwamish Village named skoh-AHL-koh, which means Confluence.

PSESD recognizes that our federal government has stolen land and broken treaties, especially the treaties of Medicine Creek and Point Elliott. We are committed to creating a racially just education system that educates all students on the colonization and the ultimate resurgence of Indigenous peoples' traditions and culture where they continue to be an integral part of today's society. By learning to lead with transformational values and disrupting patterns of white supremacy, PSESD calls to action the practice of Seventh Generation thinking in honoring the people and land.





General Information about RFP Process

King County-DCHS will tentatively release the Request for Proposal (RFP) for King County Promise--Phase 1 online in Fall 2021 for partnerships interested in implementing the King County Promise model in the fall of 2022. RFP details are still being confirmed.

Get acquainted with the DCHS RFP process:

- Virtual Info Session: Once the RFP is released, DCHS will host virtual info sessions for interested
 applicants to learn about the opportunity and how to apply. These info sessions will also be recorded and
 made available for viewing.
- **Technical Assistance (TA):** TA support for interested applicants will be available at no cost. Trained TA consultants will be available to assist applicants in engaging in the RFP materials, building proposals, and working with partners.
- RFP Duration: We plan to have the RFP open for 6-8 weeks to give partnerships ample time to build proposals.

 <u>page</u> to learn about how contracting works and to see any open RFPs. Proposals responding to DCHS
 RFPs are generally submitted through <u>Zoom Grants</u>.





Promise Students



K-12 students

- Whole building 10th and 11th graders in the **KCP Prioritized Population** who receive "whole school supports"
- Senior Class Cohort Students complete a Promise Student Pledge by fall of 12th grade year
- Pathway Partner Cohort Students who plan to attend the partner CTC

Opportunity Youth

- Young people in the KCP Prioritized Population enrolled in a re-engagement or alternative program or not enrolled in school as indicated by completing **Promise Student Pledge**
- Not currently employed (or not employed in a job with family-sustaining wages)
- Do not already hold a two- or four-year degree

CTC students

- High School or Opportunity Youth Students in the KCP Prioritized Population enrolling from Promise Partnership high school or opportunity youth program
- Students in the KCP Prioritized Population enrolling from outside of the Promise Partnership



Advising

Utilize caseload with K12 and CBO partners to proactively communicate with promise students, and lead promise specific programming.

Staffing

Hire high quality, culturally relevant school-based Promise staff. Ensure key staff participate in regional Promise professional development and continuous improvement coordination.

Data

Adopt Promise case management data system or ensure alignment and compatibility of current system with shared Promise case management data system.

Funding

Maintain financial match at the identified match ratio for PSTAA funds towards Promise related strategies supporting Promise priority populations. Actively participate in fundraising initiatives.


Cross Partner Engagement




Partner Commitments: Advising



Community Based Organizations

- Provide case management and advising supports with district and college partners for Promise priority students using Promise strategies including:
 - Focus on supporting student timely completion of Financial Aid
 - Coordinated delivery with district and college partners to provide specific navigation supports to young people ages 16-26, not in school or working in a family wage earning job
- Utilize shared caseloads and data indicators to identify and provide coordinated supports for Promise priority students in collaboration with district and college partners
- Collaborate with Promise partner district and college to deliver bridge and orientation programming supporting Promise students directly enrolling post high school graduation and Opportunity Youth enrolling on an ongoing basis


Community & Technical Colleges

- Participate in KCP-led transition programming, academic and individual coaching and advising, participate in quarterly events, and attend modules
- Ensure that students complete required King County Promise application and participate in the onboarding process as determined by the RFP
- Lead Promise-specific bridge and orientation programming for Promise students directly enrolling from K-12 high school and Opportunity Youth, in collaboration with Promise partner high schools and CBOs
- Site-level case management and real time progress monitoring
- **Equity Stipend:** \$1000/student grants to CTC students

Partner Commitments: Staffing

All Partners

- Collaborate with PSCCN to develop and implement hiring plan for King County Promise funded staff that ensures:
 - Early, consistent input and engagement of district, college and/or organization key stakeholders throughout hiring process
 - Analysis of current student advising ratio
 - Position descriptions co-created with PSCCN for newly hired staff including regionally aligned titles,
 job descriptions, performance evaluation measures
 - Common Promise related responsibilities are embedded into job descriptions of existing staff involved in Promise delivery
- Develop an integration plan for King County Promise funded staff outlining topics including:
 - Alignment with existing organization structures including postsecondary readiness/completion teams
 - Process to ensure priority access to advising supports for Promise priority populations
 - Reporting & supervision structure
 - Funding needs and sources for ancillary costs such as equipment, technology, office space, supplies, etc.



Partner Commitments: Data



All Partners

- Establish data sharing agreements across Local Promise Partnership which allows for student-level data sharing, seamless advising support, improvement strategy evaluation, progress tracking towards Promise outcomes over time and share established data points per Promise DSA with Promise partners, PSCCN and King County
- Track and report completion of Promise milestones by Promise students as outlined by DSA (within data system to be provided or integrated into existing advising platforms)
- Implement simplified transcript transfer processes (e.g. student record exchange or integrate into a DSA)
- Administer and share results of an annual Promise student survey to understand student perspectives and improvement opportunities
- Participate in ongoing assessment of Local Promise Partnership including feedback from key stakeholders

- Track and report completion of Promise milestones of Promise students (data system to be provided or integrated into existing SIS/HSBP platforms)
- Maintain updated student roster and share with PSCCN and Promise partners on a quarterly basis

All Partners

- Develop and maintain a Local Promise Partnership funding plan that identifies:
 - Ancillary costs including equipment, technology, office space, supplies, etc.
 - Sufficient financial match and a funding plan towards Promise related strategies that support the priority populations (e.g. college & career readiness staffing, transition programming) to match PSTAA funds with both leveraged existing funds and new private funds



Partner Commitments: Cross Partnership Engagement



- Establish a **Local Promise Partnership Leadership team** focused on coordinated Promise services delivery and continuous improvement
- Use a shared governance model, establish shared responsibility and mutual accountability for service delivery, leadership and continuous improvement
- Designate and ensure active participation of key leadership representatives
- Ensure active participation of Promise funded staff and other key
 postsecondary transition staff in PSCCN led Regional Promise Network
 provided professional development, continuous improvement and best
 practice sharing convenings

Partner Commitments: Cross Partnership Engagement

- Complete initial partnership assessment highlighting:
 - o Demographics of Promise priority population and postsecondary readiness/completion outcomes
 - Status of existing postsecondary readiness/completion system including advising initiatives, advisor ratios, and allocation of state funds towards advising staff
- Co-create Promise delivery plan in partnership with PSCCN including:
 - Racial justice informed service delivery approach
 - Proposed alignment of Promise activities and strategies with existing postsecondary readiness and completion strategies (ie., TRiO, CCLI, GEAR UP, UWKC benefits hubs, Guided Pathways, MESA)
 - Plan for student advising ratios at targeted support and outcome tracking for Promise priority populations
 - 1:100 ratio to Promise priority students through 1-1 case management and school wide strategies
 - Shared service delivery between CBO and District and/or CTC partners
 - Continuous improvement benchmarks and expectations
- Develop and regularly monitor individual and partnership improvement plans outlining actions to close opportunity gaps for Promise priority students


- → Ensure overall cohesion across multiple program areas and partnerships
- → Maintain a clear & consistent focus on addressing equity gaps
- → Support the efficient & effective use & leverage of PSTAA & private funding

Roles:

- Technical assistance, partnership support, professional learning, high quality materials
- Facilitate system improvement, continuous improvement, & cross system policy alignment
- Improve access to data and facilitate practitioner-led cycles of inquiry and improvement
- Communications & private fundraising and support high leverage of local public/private
- Advocacy & sustainability: model needed service levels and advocate for state investment
- Convene King County Promise advisory group and collaborate closely with King County

Continuous Improvement Leadership Structure

- **1. Youth Advisory Group:** To serve as guides and reality checks on programmatic decisions, messages, and to highlight common barriers.
- 2. Promise Practitioners Improvement Network: To support and implement programming at their respective institution and to develop a culture of learning and a desire to improve operational practices and processes related to efficiency, effectiveness, and student outcomes
- 3. Local Promise Network Leadership Team: To address in-system and partnership level barriers that emerge as a result of KCP implementation
- **4. Regional Promise Network Leadership Team:** To support cross system learning and best practices in order to address partnership level barriers that emerge as a result of KCP Implementation.
- **5. Data Work Group:** To support data sharing and analysis (e.g. Data Accountability/IR lead)
- **6. Funding Committee:** To support long term sustainability of promise funding through institutional matches and philanthropic donations (e.g. Foundation Director, Development Director, etc.)




Forming Partnerships

Forming Partnerships

- Elements to consider when forming partnerships (from YDEKC checklist, p. 13):
 - Shared vision & leadership
 - "We know where we are going and we share responsibility through genuine collaboration."
 - Aligned, responsive implementation
 - "We row in the same direction and continuously adjust to changing conditions."
 - Shared accountability for success
 - "We manage for impact and sustainability and keep each other accountable."
