Procedures:

1. Page 4 of 44: Purpose
 - a. Page 4 of 44: Replace "The successful firm(s) shall understand that the fees associated with projects RFQ-23-001 – 011 will be based on a fee percentage in accordance with the Owner approved fee schedule as follows:" to "The successful firm(s) shall understand that the fees associated with projects RFQ-23-001, RFQ-23-002, RFQ-23-003, RFQ-23-004, RFQ-23-005, RFQ-23-006, RFQ-23-007, RFQ-23-008, RFQ-23-009, RFQ-23-010, and RFQ-23-011 will be based on a fee percentage in accordance with the Owner approved fee schedule as follows:"
2. Page 8 of 44: Copies of Proposals Required if Hand Delivered or Mailed:
 - a. Replace "Quantity of (8) proposals should be submitted in binders" with "Quantity of (6) should be submitted in separate binders or bound separately."
3. Page 41 of 44: General
 - a. Replace "RFQ-23-13-001 - Independent Testing Agents" with "RFQ-23-13-001 - Geotechnical and Independent Testing Agents"

Questions:

1. Question: Do you mind sending me the standard RFQ form that we have to turn in. I believe it starts on page 22 in the advertisement.?

Answer: Yes, this will be made available on the APSB website.

2. Question: For Professional Services (RFQ-23-013), is geotechnical engineering (soil boring, etc.) included under "Testing Agents" (RFQ-23-13-001)? Or is RFQ-

23-13-001 for construction testing only? Or is geotechnical engineering separate from construction testing under RFQ-23-13-001??

Answer: See Addendum 1; Procedures Item 3.

3. Question: Does a separate package need to be submitted for each project as a testing agent? Or can one form be submitted for all projects?

Answer: No, a separate package does not need to be submitted for each project as a Testing Agent. Please note that RFQ-23-13-001 - Independent Testing Agents is for an Indefinite Deliveries Contract with APSB, not a specific project listed for the 2020 Bond Program.

4. Question: Are there any requirements for small, minority for local business participation in this procurement?

Answer: No. Although APSB does not impose specific requirements or small, minority or local business participation in this procurement, the APSB urges the prime contractor to use Louisiana vendors, including small and emerging businesses, if practical.
