## Upcoming Referendum for Turf and Track

As you may know the turf field and track surfaces are much past their normal life expectancy, nearly 8 years past that time.... On November 2, there will be a ballot question and an opportunity to change that .....

Shall the Order entitled "ORDER AUTHORIZING ISSUANCE OF UP TO \$1,900,800 IN BONDS OF THE TOWN TO FUND THE COST OF THE HIGH SCHOOL TURF FIELD AND TRACK REPLACEMENT" be approved?

We hope you join us in our efforts to spread the word to Vote on November 2. I am not sure if you are aware but our turf/track facility is in such poor condition that we do not know season to season whether it will be playable or not.

#### **Project History**

The track was first installed in 1979. In 2006, the track underwent a second resurfacing and the original turf was installed. Since then, there has been ongoing maintenance to support the active use of both amenities. A typical lifespan for a turf surface is eight- ten years (reached in 2016). It has surpassed its lifespan and is beyond the point of being remedied by general maintenance alone. There are safety concerns brought on by the deterioration of surface material and tripping hazards on the

field.

Sports and activities are vital to the education of students to help support well-rounded and civic minded adults. Students learn lifelong lessons that complement the academic lessons taught in the classroom, and these programs cost just over 2% of the overall school's budget. We are proud of our school system as people move to Scarborough in part, because of its schools and our athletics/activities programs. **Good schools make good communities.** 

#### **Impact if Approved**

This renovation project does not only benefit student athletes; it benefits the community and user groups of all ages. There are nearly 18 different groups who use the turf and track, ranging from students, athletes, community services program participants, residents, youth sports leagues and clubs. From the Fall of 2018 to Summer of 2019, this amounted to 1,100 hours of scheduled use for various activities and programs.

#### **Impact if Not Approved**

If not approved, the damage will worsen and cost to fix will rise. This was proven true when it was not approved in the 2019 referendum at \$1.2 million. The current project cost is an estimated \$1.9 million. It also faces the potential for closure when safety risks become too high. Closure of the facility would impact programming offered through the School Department as well as increase the demand on other town fields. Closure would also affect much of the youth programming offered through Community Services and private clubs. Additionally, there would be potential costs for the schools to rent facilities outside of Scarborough to continue offering existing athletic programs.

The decisions we make on November 2nd related to the turf/track project affect our children's daily lives. Elections are our chance to stand up for what matters most to us and to have an impact on the issues that affect us, our communities, our families and our future. Please be educated when you go to the polls on November 2nd to vote....

#### Communication about Positive COVID Cases in Our Schools

As we did last year, Scarborough Public Schools will continue provide information to you on a weekly basis about the number of positive COVID cases in our schools, as well as the number of people who are identified as close contacts. This year close contacts are being communicated in 2 columns, whereas the Maine CDC exempts people from school quarantine if they have classroom only contact (since we are universally masking), are fully vaccinated, or actively participating in pooled testing.

#### Pooled Testing Information and Reminders

Pooled testing started successfully at our K-2 schools, with Blue Point and Eight Corners testing on Monday, and Pleasant Hill testing on Tuesday. We are now working on expanding to Wentworth School, with a target date for the week of October 18,

#### Assessment Updates

#### Fall State Testing

This year, all Maine public schools are required to administer the Maine Educational Assessments or MEAs for English/Language Arts and



Mathematics to all students in grades 3-8 and 3rd year of high school. These tests measure key knowledge and skills in the areas of our curriculum which reflect the Maine State Standards.

New this year, students will be taking these assessments in the fall and again in the spring for the purpose of measuring their growth specifically in the areas of reading, language usage, and mathematics. We are excited about this development as the assessments themselves are shorter in duration, results are more quickly available, and the focus is on student growth over time.

The MEAs for English/Language Arts and Mathematics are the <u>NWEA MAP Growth Tests</u>. Students will be taking these tests online while in school between Oct. 4 and 29th and then again between May 2 and 27th. School leadership is working hard at scheduling to minimize the disruption to the instructional day. Students will be taking three assessments, Reading, Language Usage, and Mathematics. Each test session will take approximately 45-60 minutes. More specific details will be provided by each school.

The data is very important to us as it will assist us in making improvements to our curriculum and instruction. As the Literacy and Math results will be available to teachers sooner than in the past, the

information will assist teachers in planning for their students' instruction this fall as well as measuring growth in the spring. While an 'opt out' option is not available, we do wish to partner with parents to make decisions in the best interest of our students. If you have concerns regarding your child's participation, please contact either your child's guidance counselor, principal, or me.

We appreciate your support as we look forward to using the data from these assessments to inform teaching and learning.

## i-Ready Testing Continues at Certain Grades

This year students in grades K-2 and 9 will continue to use the i-Ready Diagnostic Assessment. i-Ready is an online program for reading and mathematics that will help us determine your child's strengths and areas



for growth and personalize their instruction. i-Ready allows us to meet your child where they are. The i-Ready Diagnostic is an adaptive assessment that adjusts its questions to suit your child's needs. Each item a student receives is based on their answer to the previous question. For example, a series of correct answers will result in slightly harder questions, while a series of incorrect answers will yield slightly easier ones. The purpose of this is not to give your child a score or grade but to determine how to best support their learning. It is not a placement test. Our teachers use the information to help them identify where to target their instruction.

There are two sessions, one for reading and one for mathematics. Each session is about 45 to 50 minutes. And similar to the State NWEA tests, we assess in the fall (Oct.) to learn more about what a child knows and in the spring (May) to measure and celebrate growth.

For students in grades K-2, i-Ready Personalized Instruction provides students with online lessons based on their individual strengths and areas for growth as a result of the assessment. These lessons are interactive and provide strategic support to keep your child engaged as they learn. Teachers can also adjust the lessons if necessary. This online instruction tool is available throughout the year to support their growth in both reading and mathematics. More specific information will be sent via your child's school and teacher. #### 2021-2022 Breakfast & Lunch Ordering Protocols

As a general reminder, all breakfast and lunch meals for all students in Scarborough Schools are free for this school year 2021-2022. All existing students whose parents have an account will be able to order breakfast and lunch using the same procedure as last year, from the Nutrislice app on a device or at <a href="https://www.scarboroughschools.org/">https://www.scarboroughschools.org/</a> (at the top of the page click "Quick links", then go to School Lunch for all meal menus).

All Kindergarten and new students to the district will have to make a Nutrislice account through the Nutrislice app or through <a href="https://scarboroughschools.nutrislice.com/menu/create-account">https://scarboroughschools.nutrislice.com/menu/create-account</a> before they can order breakfast and lunch. Parents will need the child's ID# before they can start the registration process.

For breakfast meals in all of our schools, you can order online on the same day before 6:30 AM, while for lunch meals, you can order online on the same day before 7:30 AM. You can order meals for the day, or set up a weekly or monthly plan for meals to be provided to your children. The menus for all meals for a new month will be posted on the school's website and on the Nutrislice app the last Monday at the end of the previous month.

Each school has created their own system for their lunch disbursement. They are continually reviewing the process and making modifications as needed. Please be patient with our school staff as they work towards improving and refining their daily lunch routines.
