What quantities are estimated in the annual proposal, our supply is limited. If our product still meets your interests with our current inventory, we can continue with a bid.

PPE items do not need to be made in the USA; however, equipment quoted must comply with COVID-19 PPE guidelines established by the Centers for Disease Control (CDC) and Wayne County Health Department. Suppliers are expected to include product specifications documents for all items quoted in proposal to indicate compliance. As for estimated quantity, WCRESA does not have an estimate or known quantity for PPE. Items will be shipped to multiple locations. The intent of this RFP is to have all items ordered by, and delivered directly to, the individual public school districts and charter schools in Wayne County, Michigan. While deliveries will be made directly to the charter schools, public school districts typically have centralized locations for delivery.

27. Are there protocols in place for inside deliveries due to COVID-19, masks requirements, vaccination cards, ID cards any special guidelines.

Every school district and charter school has their own delivery protocols related to COVID-19. WCRESA has a loading dock where supplies will be scheduled for delivery. Masks are currently required. Further protocols will be provided (for each school district and charter) to the awarded supplier.
