- Maintain a thorough understanding of Internet protocols (DNS, DHCP, IPv4 and IPv6, HTTP, VPN, etc.)
- Configure and setup switches, firewalls, and security appliances for access to vital business applications
- Design, setup, configure, and monitor multi-VLAN HP/Cisco switching environments.
- Design, setup, configure, and monitor multi-VLAN Ruckus wireless network for support of data, voice and video applications.
- Maintain a thorough understanding of IPv4 NAT as it pertains to LAN, DMZ and WAN.
- Assist in the design of separate client environments including subnets, DHCP, DNS, ACLs, etc.
- Configuring and installing client and server network software for upgrading and maintaining network and telecommunication systems.
- Responding to inquiries from staff, administrators, service providers, site personnel and outside vendors etc. to provide technical assistance and support
- Troubleshooting malfunctions of network hardware and software applications, telephones, and security systems to resolve operational issues and restore services.
- Upholds board policies and follows administrative procedures.
- Performs other specific job-related duties as directed.
