The district held parent forums on July 28 and 29, 2021 as an opportunity to discuss prevention and mitigation strategies for in-person learning, CDPH School Guidance, and strategies to address social-emotional and academic needs.

On August 4, 2021, a public forum was held at the district board meeting at which time members of the school community gave input on school opening and operations for the 2021/22 school year. The COVID-19 Prevention Plan was updated and adopted at this board meeting.

On September 16, 2021 a general education partnership meeting was held virtually. Specific invitations were sent to students and their families, as well as school staff, via school newsletters and notification systems. Participants had an opportunity to address the group via Zoom.

Specific email invitations were sent on September 7, 2021 to April Carmelo, representative of the Tribe, Austin Preller, Foster Youth/Homeless advocate, and Christian Patz, SELPA director (representing the interests of students of disabilities).

The district will consult with the County office of Education for ongoing input from the American Indian Advisory Council which meets on October 29.

A flyer invitation for the meeting was posted publicly on the district and school websites and posted outside the district office and school offices.

A public hearing on the proposed ESSER III Expenditure Plan was then held at the October 6, 2021 board meeting.

A description of how the development of the plan was influenced by community input.

The development of the 2021/22 Independent Study Program was influenced by parent input at forums. This plan provides funding for independent study teachers. Parents wanted assurance that their student would have priority consideration for returning to previous school they attended in person. Previous needs identified in parent, student, and staff surveys (February 2021) were included in decision-making regarding the plan, including counselor support and additional academic supports. The community overwhelmingly prefers in-person instruction and indicated a need for social-emotional supports for students. To support safe, in-person instruction, additional nurses and school psychologists are included in the plan. School counselors at each site will further support social-emotional needs. Teaching staff and librarians will address academic impacts of lost instructional time. Funds are also needed to supplement costs of summer learning to address unfinished learning. Community members have given input on assurance that safety protocols will be followed at school, so additional funding will also be used for safety measures such as, PPE, staff & student testing, contact tracing, cleaning/disinfecting. Teachers have expressed input in favor of continuing with lower class sizes. Both union representatives consulted with their members and shared support for an employee vaccine incentive.
