Dear SPASD Community,

It has been great to have more students in our schools over the past few weeks. Our staff are balancing virtual and in-person learning during a pandemic and ever-changing public orders. In addition, our District and community continue to make progress on committees that are integral to the opening of Sun Prairie West High School and shifting to three 6-8 middle schools in the fall of 2022. The Secondary Boundary and Bell Time Task Force (SBBTTF) has been meeting since September and has completed the boundary part of their charge. Their recommendation was accepted by the Board of Education on February 22, 2021, and the new boundaries will take effect at the start of the 2022-2023 school year.

With the accepted recommendation, school attendance boundaries have shifted, and there are some changes that we want you as community members to be aware of. This communication includes some background on the work that led to these changes, a map for you to identify the schools that your neighborhood will attend, and answers to some frequently asked questions. Thank you to the task force, community, and all District employees who engaged in this important work!

CHARGE OF THE SECONDARY BOUNDARY AND BELL TIME TASK FORCE

The School Board created an ad hoc Secondary Boundary and Bell Time Task Force. The citizen-based group consists of School District residents serving in an advisory capacity to the administration and School Board. The task force will review data and create and present a recommendation for School Board consideration, deliberation, and subsequent action for enrollment boundaries that will be effective September 1, 2022, after the District completes referendum projects that add an additional high school and an additional middle school. Then the task force will transition to a bell time study, reviewing bell times at the elementary, middle, and high school levels for any individual or group bell time adjustments that may be advantageous for operational, student behavioral, safety, and/or fiscal reasons. 

FREQUENTLY ASKED QUESTIONS



WILL FAMILIES LIVING IN THE DISTRICT HAVE A CHOICE IN WHAT SCHOOL THEIR CHILD/REN WILL ATTEND?

The School Board approved a recommendation from the Student Migration Planning Team on October 28, 2019, that 100% of District students will transition to their boundary area school at the start of the 2022–2023 school year. Given the amount of change required to implement the new boundaries, grandfathering options will not be offered. According to District policy, there is no "voluntary placement" option for families to choose a school other than their boundary area school. School assignments will be based on the student's residence.



THE BUILDING CAPACITIES FOR ALL THREE MIDDLE SCHOOLS ARE LISTED AS THE SAME. IS THE GOAL TO KEEP THEM AT SIMILAR ENROLLMENT AND CAPACITIES? DOES CARDINAL HEIGHTS HAVE ADDITIONAL CAPACITY FOR GROWTH?

Yes, the goal is to keep all three middle schools at the same capacity with similar enrollment. While Cardinal Heights is a larger building, it will be housing multiple distinct entities, including Central Heights Middle School, Prairie Phoenix Academy, a Professional Learning Center, and the Employee Wellness Clinic.



WHY CAN'T ALL STUDENTS ATTEND THEIR CLOSEST SCHOOL?

The west side of our District is more densely populated than the rest of the District (see SPASD Student Density Heat Maps). This most directly impacts those living closer to Sun Prairie West High School and Prairie View Middle School. Placing students at their geographically closest schools would result in a severe enrollment imbalance between the three middle schools and would put Prairie View at capacity on day one of the new boundaries. Additionally, the "equitable distribution of socioeconomic status and racial composition" criterion would not be met. Finally, placing all students at their geographically closest school would result in more cohort splits (five elementary schools would send their students to two middle schools, and C. H. Bird would split to all three). Imbalanced enrollment, socio-economic and racial inequities, and more cohort splitting are also issues at the high school level.



HOW DOES THE DISTRICT PLAN TO ADDRESS AND ASSIGN STUDENTS WHO LIVE OUTSIDE THE DISTRICT AND APPLY FOR OPEN ENROLLMENT?

Acceptance through the state open enrollment program is not a guarantee. Open enrollment requests can be made to the District but not for a specific school. Although a school preference may be specified, factors considered when the District accepts and places students include school space, availability, class size, growth, and proximity for those areas that border our District. In the end, we want to make sure that our open enrollment process has procedure integrity.



WHAT IS THE TRANSITION PLAN?

We recognize that a smooth transition plan is important to our families. Our comprehensive plan will be available in the spring of 2022.

SBBTTF I Bell Time Analysis

Effective March 3, 2021, the task force transitioned its efforts to bell time analysis. Given the operational nature of bell times, criteria will be informed by administrative guidance, and the proposed evaluation criteria and proposed solution will be submitted to District administration for their discussion, potential modification, and acceptance.
