Title I & ESSA (Every Student Succeeds Act)

- Title I is part of the Elementary Secondary Education Act passed in 1965 and is authorized under the *Every Student Succeeds Act* (ESSA) of 2015
- Title I funds can be used to:
 - Provide all children significant opportunity to receive a fair, equitable, and high quality, well-rounded education, and to close educational achievement gaps.
 - Improve, support, provide training, and/or involve parents in the following; math, ELA, reading, English Language Learning, science, attendance, preparation of students for advanced coursework, school climate interventions, counseling programs, graduation, etc.
 - Provide a supplemental resource for the regular school year, extended day, or summer extension

Title I & ESSA...continued

- Title I School Requirements:
 - Collect & analyze student achievement data
 - Involve parents in the school planning & decision making process
 - Design a school plan that includes;
 - i. Braiding of all resources,
 - ii. Ensures all teachers are highly qualified in their content areas,
 - iii. Provides evidence based teacher professional development,
 - iv. Ensures that students who are English Language Learners are
 - 1. Proficient in English Language &
 - 2. Successful in Content Knowledge, and
 - v. Embraces authentic parent engagement
