## **Board of Education celebrates 73 CCPS retirees**

The first day on the job for Concitta Walls was Sept. 5, 1969, and she was 18. William Diggs — the namesake of a Waldorf elementary school — stopped by her house over the summer. He knew her mother had health concerns and Walls, who had just graduated high school, would be looking for a job. She started at the F.B. Gwynn Educational Center and stayed there until 1986.

From there she moved to the Jesse L. Starkey Administration Building to work for the Training for Effective Transition, a program that helped support special education students, teaching them job coaching and other skills they could use after they left

school. For the past 26 years, Walls has been the college and career advisor at Henry E. Lackey High School where she worked from 1992 to 2019, when she retired after 50 years of service to CCPS. She's helped students apply for college, enlist in the military, get apprenticeships and enter the workforce. Other times, she lent an ear. "Students, teachers ... All they want you to do is just listen," she said. Walls was among the 73 CCPS employees recently honored by the Board of Education at a recent retirement ceremony held June 6.


## Henson's Carroll named Vice Principal of the Year

## Random, on-going criminal history screening of employees starts in July

Beginning in July, the Charles County Public Schools (CCPS) Office of School Safety and Security and Human Resources are expanding the school district's on-going criminal history screenings of employees.

Screenings will be completed randomly and on a revolving basis.

Starting this summer, the Office of School Safety and Security will screen approximately 1,200 employees each year and notify selected employees by email prior to conducting the background check.

CCPS has required all employees to submit to criminal background checks as a condition of employment dating back to the 1980s.

Prior to 2018, CCPS relied on fingerprint iden-

tification technology to conduct initial and ongoing background screenings.

However, criminal justice reforms over the last two decades have challenged the comprehensiveness of the fingerprint-based screening.

To fill the gap, CCPS has contracted with a company that will complete additional background screenings on employees.

CCPS has a self-reporting policy of any arrest and/or criminal charge within five days.
