Maryland AP scores continue to hold top spot

Governor Martin O'Malley took La Plata and North Point high school students on a victory lap Feb. 10 during a short Telepresence conference announcing Maryland as top in the nation for Advanced Placement (AP) success.

"Thank you. I get to do the victory lap for you, but you've done the hard work," O'Malley told AP teachers and students during the Telepresence chat. The governor announced Maryland students have led the nation in success on AP exams for eight consecutive years.

"This morning, the College Board's "10th Annual AP Report to the Nation" came out, and for the eighth year in a row, Maryland made the most success in students achieving three and above. Almost 30 percent of seniors scored three and above on one AP exam, well above the national average of 20 percent," O'Malley said.

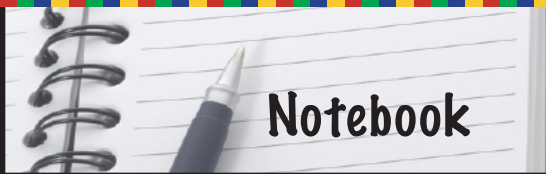
At La Plata, where AP students and teachers participated in the conference, student success is even higher. La Plata seniors who

earned a score of 3 or higher on one or more AP exams reached 37.8 percent, a number that has steadily increased since 2008. The percentage of scores 3 and above for tests taken by all La Plata students in 2013 was 53.8 percent.

La Plata senior Sarah Holmes says La Plata students are successful because they work hard and have dedicated AP teachers. She said she strives to score a 3 or above, which is the score at which many higher education institutions award college credit for high school students. Holmes credits La Plata's AP teachers for her success, saying they work around student schedules, hold after-school study sessions and, "make it easy for students to succeed."

Holmes, who is taking multiple AP classes this year, shared experiences her AP teachers have made possible, including meeting via Telepresence with professors nationwide who relate real-world conflicts that help students make connections to what they are learning in AP Human Geography.

Schools celebrate reading

Charles County Public Schools celebrates Read Across Charles County this school year on Friday, Feb. 28. The annual event is a reading motivation and awareness program that invites children in the community to celebrate literacy and reading, and the birthday of the famous children's book author Theodor Geisel, better known as Dr. Seuss. Each year, the school system coordinates the event in conjunction with the National Education Association's (NEA) Read Across America Day activities. This is the 17th year that the NEA has celebrated reading through the nationwide event.

Sonya Ford named State Counselor of the Year

Sonya Ford, a school counselor at Matthew Henson Middle School, was recently named the 2014 Maryland Middle School Counselor of the Year by the Maryland School Counselor Association (MSCA). The award recognizes school counselors for outstanding achievement and service to students, and for providing leadership in the development of existing and future counseling services.

Ford began her school counseling career with Charles County Public Schools in 2008 as a counselor at North Point High School, and transitioned to Henson in 2012. During the past six years as a CCPS middle and high school level counselor, Ford has worked with students on academic, personal and social goals, and career development. She also focuses on implementing and supporting programs that build positive relationships.

Last year, Ford launched a program called Lunch and Learn/Dine and Discover. As part of the program, parents are invited to visit Henson for one hour, either during lunch or after school hours, to meet with the counseling department. Ford also works with the counseling department to send monthly newsletters to parents, man-

age a girls mentoring and peer mediation program and coordinate schoolwide events such as College Day and Career Day.

Ford said she is proud to represent Henson. "I am humbled and honored to receive this award. However, I consider this award an award for all the school counselors in CCPS," Ford added.

This award is not the first recognition

Ford has received for her work in school counseling. In 2011, she was nominated as a candidate for the American School Counselor Association's (ASCA) School Counselor of the Year award. In 2004, she was named the Maryland Elementary School Counselor of the Year by the MSCA. Prior to beginning her counseling career with CCPS, Ford held school

counseling positions in both Howard and Prince George's counties.

Ford is a member of the Charles County Commission for Women and is the social media chair for the MSCA. She also holds national school counselor certification and served as an advisory team member for the College Board's National Office of School Counselor Advocacy.

She will be honored by the MSCA at their annual conference on March 28.

At North Point, senior Ethan Kriemelmeyer talked with O'Malley about his AP computer science class and explained how it allows students to enhance their ability to code and their computer science skills. The College Board has selected Charles County Public Schools to pilot AP Computer Science Principles, which will be offered at North Point and Westlake high schools next school year.

O'Malley urged the students to pursue computer science classes, saying there is a great new world waiting and jobs aplenty for those who learn computer science skills.

Mary Bailey, the Charles County Public Schools 2013 Teacher of the Year, joined the governor and State Superintendent of

Schools Lillian Lowery for the conference. Bailey commended the students for taking on the rigor and challenges of AP and AP testing. Superintendent Kimberly Hill echoed the praise to the La Plata students following the conference. She lauded them stepping up and choosing to take rigorous Advanced Placement Courses. "It's hard, and a lot of people don't take hard classes."

The College Board's Advanced Placement Program, which began in 1955, allows students to pursue college-level studies while still in high school. Charles County Public Schools offers 30 AP courses. In 2013, Charles County Public Schools administered 3,759 AP tests, which is 193.7 percent higher than in 2002.

School system recognized for energy savings efforts

As part of Southern Maryland Electric Cooperative's (SMECO) Demand Response Program, Charles County Public Schools recently received a \$286,075 incentive for energy savings efforts. The Demand Response Program is coordinated through SMECO's contract with Comverge, Inc., an independent company that provides clean energy solutions through demand response and energy efficiency. Tripp Warner and Jennifer Raley, representatives from Comverge and SMECO, presented the school system with a check during the Feb. 11 Board of Education meeting.

The incentive is payable to the school system in two portions. Fifty percent is provided as a bill credit for Charles County Public Schools with SMECO. The remaining 50 percent is provided to the school system from Comverge, Inc. and is used for various system facility projects. The program focuses on reducing electricity use during peak demand hours, which results in energy savings, and is in place during the months of June through September.

This is the third consecutive year that Charles County Public Schools has participated in the program. In 2012, the school system received an incentive for more than \$262,000 from participation at

all schools, centers and buildings. The program was piloted at 12 schools and buildings in 2011 and initially resulted in an incentive totaling more than \$145,000. The program was launched systemwide in 2012.

Under EmPower Maryland, Maryland's five major utility companies developed and implemented energy efficiency and demand response programs that include electric bill rebates for energy efficiency investments, audits and services. The goal of EmPower Maryland is to reduce power consumption 15 percent by next year.

The school system also participates in SMECO's Business Solutions program, which provides incentives to businesses that make efficiency improvements to their facilities. All non-residential customers who receive SMECO service are eligible to participate in the Business Solutions program, but interested customers must apply for program participation.
