Travel, conference reports

Beginning this month, any travel mileage made after July 1 will be paid at \$.555 per mile, up from \$.51 per mile last school year. An updated mileage form is located on the forms database on the system Web site, and must be used in order to obtain the new rate. The form has also been revised and includes additional space for entries and an area to be filled in with the title of the employee. The form is for business travel only and should be submitted on a monthly basis. If an employee's total monthly travel is less than \$10, employees can submit a form every 60 days.

Additionally, conference travel must be submitted on a separate form. A new mileage guideline is also available on the forms database located on the staff services page of the system Web site at <http://www2.ccboe.com/staffservices/forms.cfm>.

Kiessling began her career with Charles County Public Schools as a social studies teacher at Matthew Henson Middle School. She transferred

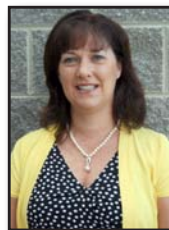

State releases Maryland School Assessment data

Elementary and middle school students at Charles County Public Schools (CCPS) continue to work toward 2014 goals on the reading and mathematics Maryland School Assessment (MSA). In elementary schools, 86.5 percent of students scored proficient or advanced on the reading MSA and 84.1 percent on the mathematics test. In middle schools, 82.8 percent scored proficient or advanced on the reading MSA and 79.5 percent on the mathematics test.

"Thanks to the hard work of our outstanding staff and students, Charles County is making progress, especially in the areas of special education and free and reduced meals (FARMS) subgroups," said Superintendent of Schools James E. Richmond. "We still have a lot of work to do, and the improvement targets continue to get harder to meet as schools reach the 80 and 90 percent levels."

The MSA reading composite score at the elementary level has risen 22 percentage points since 2003, when the tests first started. Elementary mathematics proficiency has increased by 19.9 points. Middle school reading proficiency has increased 16.6 percentage points since 2003, while middle school math proficiency has risen 33.4 points.

The MSA scores were released as part of the Maryland 2011 Adequate Yearly Progress (AYP) report, which uses the assessment data to determine if schools have met federal testing targets. The tests are required by the federal No Child Left Behind Act (NCLB) that charts the progress of the overall student population in the grades tested as well as for students receiving special services and by racial subgroups. Scores are reported for a total of 12 tests, six reading and six math, taken in March by students in grades three through eight. Scores are expressed as the percentage of students who scored at or above the proficiency levels, which were set in 2003. The annual measurable objective (AMO) is the yearly benchmark established by the state for school systems to meet their goals by 2014. If one subgroup in a school does not meet the goal, the entire school does not make AYP.

ADEQUATE YEARLY PROGRESS

- Overall, 13 of Charles County Public Schools 29 elementary and middle schools

met all testing targets and made AYP.

- Schools that did not meet every one of the overall or subgroup targets in mathematics or reading for two or more consecutive years are identified for School Improvement. Schools exit School Improvement if they meet every one of the area and subgroup targets for two consecutive years. Four of 29 CCPS schools have been identified as schools in improvement.

- In CCPS schools, C. Paul Barnhart Elementary School, which is a Title I school, entered into improvement status and is required to offer school choice to parents. Letters to all Barnhart parents will be sent by July 6 outlining their options for the next school year. Only Title I schools in school improvement are required to offer school choice. There are no CCPS schools in the "priority" stage, which is the most severe level of School Improvement. - The targets that all students and subgroups had to meet went up this year, causing more CCPS schools to miss making AYP. Five of the schools that did not make AYP missed making it in only one subgroup.

"Schools face much greater challenges with meeting AYP as targets grow higher. Schools that did not meet AYP are not failing schools, but simply have areas where the teachers, staff and students must put more of a focused effort," said Richmond. "We will work closely and collaboratively with these schools to address these areas in the coming year."

Students in the special education and free and reduced meals (FARMS) subgroups also made significant gains on both the reading and mathematics tests. For a breakdown, read the press release posted on the CCPS Web site, www.ccboc.com/pr.

Stone, Turner named 2011 National Promising Practice winners

Eva Turner Elementary School and Thomas Stone High School were recently named 2011 Promising Practice Award winners by the Character Education Partnership for their efforts in character education. They were selected from more than 500 schools nationwide and are among 260 to receive the honor this year. The award recognizes schools and districts that have developed specific, unique and effective educational practices that promote character development.

Stone was recognized for their class character competition called "The Golden Stone," which focuses on student service learning and service to the community. As part of the competition, students compete monthly in categories such as attendance, food drives, blood drives, clothing drives and student grade point averages in an attempt to earn the most points as a class to win the overall prize - the golden stone.

The competition was implemented during the 2007-08 school year and is spearheaded by the student government association. The implementation of the program has resulted in an increase in attendance and decline in suspensions over the past four school years. Additionally, Stone has experienced an increase in student community involvement, teamwork among classes and sportsmanship.

Turner was honored for their recess station program, which was implemented in 2008 to reduce the

number of referrals occurring during recess time. John Sine, physical education teacher at Turner, designed game stations for students to participate in during recess and works with students during their physical education period to learn about the games and skills needed to participate. The program promotes teamwork and includes activities and games for students in prekindergarten through grade 5.

Students also learn appropriate social skills and better transition from the classroom to periods of unstructured time, such as recess. As a result of the program, recess office referrals have declined and students spend more time during recess working in groups at the recess stations.

The Character Education Partnership sponsors the annual program to showcase innovative best practices that promote character education. Turner and Stone, along with the other national award recipients, will be honored at the 18th National Forum on Character Education in October. For more information on national character education programs, visit www.character.org.

Earlier this year, both schools were also recognized by the Maryland Center for Character Education (MCCE) for their efforts in character education and creating a positive school climate. Turner was named a 2011 Maryland School of Character, and Stone was named a 2011 Emerging School of Character awards recipient.
