System seeks naming suggestions for new school

The Charles County Public School-Naming Advisory Committee is seeking community input and suggestions for naming a new elementary school that will open in 2008 and will be built off Piney Church Road in Fairway Village in St. Charles.

Board of Education policy requires that schools shall have names of either deceased persons or places of significance to Charles countians.

Anyone wishing to recommend a name to the committee must present written documentation, not to exceed one typewritten page, front and back, of the significance of the proposed name. Supporting documents may also be included, but please do not send original copies. No materials will be returned. A committee, composed of eight members appointed by the Board, will research, screen and recommend names to the Board. The Board of Education will make the final selection of a name for the school after the committee presents its recommendations.

Lackey graduate creates Suspension with new book

Robert Westfield, a 1990 graduate of Henry E. Lackey High School, made his literary debut in bookstores this week with the publication of his book, *Suspension*.

Situated in New York City, the book is described as a "dark comedy about a young New Yorker's failed attempts to isolate himself from stalkers in a city filled with imposters, ax murderers and a fanatically religious, overprotective mother."

Westfield takes readers on a tour of New York City through a series of twists and turns and the adventures of Andy Green, a multiple choice test writer. Local readers will get a hint of Westfield's Charles County roots through references to his hometown and Andy's recollection of childhood events.

After graduating from Lackey, Westfield received his degree in theater and English from Columbia University. He is a playwright and a Manhattan tour guide. He plans to visit Charles County in early November and will speak with AP English students as well as at several county events.

State offers AP tests as option to high school assessments

The Maryland State Department of Education, with support and preliminary approval from the U. S. Department of Education, will offer high school students another option for passing the State's endof-course High School Assessments (HSA) this school year.

State Superintendent of Schools Dr. Nancy S. Grasmick said students who take certain Advanced Placement (AP) exams will be able to meet the HSA graduation requirement if they receive a score of 3 or higher on the AP exam. Students will need to take specific AP exams in order to make a substitution. Maryland is among the first states in the nation to offer this option to students.

"Maryland has the highest growth in AP participation in the nation," Dr. Grasmick said. "We believe that by allowing this substitution, we will be encouraging more of our students to take the highly challenging AP and IB courses and tests, ensuring that more of our students have a world class high school experience."

According to the College Board, the number of Maryland students taking AP exams has increased by 70 percent in the last five years. In January 2005, the College Board ranked Maryland number two in the nation in the proportion of graduating seniors who received a college-mastery score on one or more AP exams.

Students who entered grade 9 in 2005, this year's tenth graders, are required to pass Maryland High School Assessments in English II, algebra/data analysis, biology and government to receive their high school diploma. Students in grades 11 and 12 are only required to take the assessments in order to graduate and may substitute taking the AP exams as well.


