### **9. STAFF REPORTS** Farm 2 School Program

The OUHSD Farm 2 School Program began in 2016 under the leadership of Stephanie Gillenberg, Nutrition Services Director, and Anna Jackson, Program Coordinator. The Farm to School Program values student voices and utilizes student leadership to develop program priorities: improved student nutrition, school gardens, locally grown food, and student leadership development. By way of public and private grants and donations, there are eleven school gardens throughout the District, Nutrition Education to over 8,000 students has been provided, Garden Education to over 5,500 students has been provided, harvested over 1,500 pounds of food for nutrition education and cafeteria meals, held student activities, and supported CTE culinary programs. Annually, this program also provides field trips to local farms and agriculture companies for about 500 students. Farm 2 School maintains relationships with local farms to ensure that available resources for our students are available. This year the program also began to support staff and faculty wellness by working with the CSEBO Healthcare Committee to launch the Teacher CSA program which has provided hundreds of home deliveries of fruits and vegetables to OUHSD staff during the COVID 19 quarantine.

Trustees and Dr. DeLeon thanked the Food Services team for their presentation and for all that they are doing to help students. This program will help to expose students to multiple careers if they so choose. President Sher thanked her fellow Trustees for their support of this program.

#### Tabled

Trustees requested that Dr. DeLeon bring this resolution back to the May 13<sup>th</sup> Board meeting with amendments; therefore, no action was taken on this item.

Dr. DeLeon informed Trustees of the following compromise made within the grading guiding coalition of teachers, administrators, and members of the Board of OFTSE:

- Pass= any student who is 70% or above as per the teachers' rubric
- Credit 60 69%
- Incomplete less than 60% but giving these students ample opportunity on Edgenuity to finish only the parts they missed in class to be able to improve their grade.

Dr. DeLeon stated that students have the opportunity to take almost every course, offered within OUHSD, online. Universities have informed OUHSD that a pass/no pass, or a combination of this, will not be calculated in a students' GPA for this semester. Dr. Deleon stated she is in support of the agreement and the compromise but is not in support of this resolution as she feels the students that are not able to bump up their GPA creates a system of inequity. Dr. McCoy informed Trustees that a frequently asked questions, "FAQ", will be created for grading that will be reviewed with the distance learning committee, approximately 60 teachers, on Friday, May 1, 2020 and will be also pushed out through Principals. Trustees were also made aware that in item 6 of the resolution the percentages had to be created to verify to UCs and CSUs that a pass grade will give students A-G credit, equivalent to a C grade or 70%, and a grade of credit will not and that the teacher of record will determine what 70% means as there is no district determination. Dr. McCoy stated that the deadline to complete incomplete courses has been extended to the end of semester one of the next school year, 2020-21. Edgenuity and Oxnard Online courses will be used to facilitate completion of the incompletes so teachers of record can focus on their new group of students in the fall.

- Resolution will cover semester two and summer 2020
- Selection of Valedictorian and Salutatorian of Class of 2020 will be based upon their 7<sup>th</sup> semester GPA versus 8<sup>th</sup> semester GPA
- Students have to participate in distance learning to earn a pass or credit.
- Students will know the teacher's grading rubric once parameters have been set for the grading policy. Teachers will then inform students about how their assignments interact with the policy that has been created through this resolution and it will also help to determine what the 70% is. OUHSD hopes teachers consider participation engagement more heavily than rote numbers in returning assignments with particular scores.
- Graduating seniors will be allowed to make-up work through fall and will also be allowed credit recovery from May 1 June 2020. If further time is required, they can enroll in the senior success program through Condor HS and summer school.
- Students requesting a letter grade in place of Pass for any course can be done through a google form that teachers will push out through the course. Students will have from June 8-12, 2020 to request their letter grade. The request has to be made to the teacher within five days of the due date of the final distance learning assignment to facilitate the closing of the school year. Trustees requested additional time be allowed for a student with an extenuating circumstance. University deadlines may not be made, if this is allowed.
- Be clear in the resolution that "Credit" counts for HS graduation but it does not satisfy a specific A-G requirement.

- Transcripts will be marked with "COVID-19" under spring 2020.

- Clarification on how March 13<sup>th</sup> interacts with distance learning.
- Official notification from CSUs and UCs how they will view a pass, no pass.

The District has identified approximately 145 possible modernization, energy conservation, and construction projects for District Facilities. This includes a new comprehensive high school. The funding for these projects is Measure A Bond Funds. The following information is given to the board, staff, and public to update them on the progress of these projects and the expenditure of the Measure A Bond Funds.

Trustees inquired if there is anything that can be done to expedite the HVAC installations since school is not in session nght now or summer. Mr. Weinstein replied that ACHS is one of the comprehensive sites with a shorter installation time but that is still 30 months, OHS and PHS two-story buildings will take four years.

- Wanted to reassure the public that school calendars are a negotiated item and there is a calendar in place for next school year already.
- Thanked the district office staff for their quick responses on requested items.
- Concerned about the two week lag time for non-reimbursement of meals for students from the end of school and beginning of summer school period.
- Gave an update on the Superintendent Search Process and stated all related documents are attached to Granicus, if anyone is interested in observing them. It was also noted that the timeline at the bottom of the application is not correct, but the May and June calendar attachments are.
- Trustees decided to review the documents attached for the Superintendent Search and bring them back with revisions to the May 13<sup>th</sup> Board meeting.
- No report.
- Gave an applause to all of the faculty and staff trying to make the best out of this COVID-19 situation.
- Is happy to hear from students sharing their positive experiences under these stressful situations.
- Asked staff to note on site websites what the process is for parents to contact staff at school sites. Asked for clarification of "messages will be checked periodically".
