1. CALL TO ORDER

5. PUBLIC COMMENTS ON OPEN SESSION ITEMS

6. ACTION ITEMS

A. Consideration of Approval of the First Interim, Fiscal Year 2020-21

Motion: Trustee Herrera moved to approve the First Interim, Fiscal Year 2020-2021, as presented. Seconded by Trustee Hall and approved with a roll call vote of 4:1 as Trustee Davis was absent.

Approved

- Student enrollment has increased by 389 students, but OUHSD will not receive the
 additional funding, approximately \$3.9 million, this fiscal year. The State has yet to
 inform the district how the additional enrollment will be funded.
- The Worker Compensation rebate is due to an overcontribution from OUHSD and a low number of claims being submitted.
- Chromebooks, hotspots, monitors, keyboards, cameras or instructional programs are
 part of the expenditures for Distace Learning Instructional Supplies. These supplies
 can be requested through Learning Support Services, peer coaches or site principals.
- Dual monitors can only connect to classroom desktop computers at this time and staff are welcome to request this type of set-up.
- No new positions are being created at this time.
- Trustees reminded staff that Del Sol HS will have to be included in the multi-year budgeting.
- Additional custodians hired are paid through the CARES funding but these salaries will be worked into the general fund in the future.

Trustees thanked Ms. Thomas, the accounting staff and principal's secretaries for all of their hard work they put into the budget.

C. Consideration of Revision to the Superintendent's Contract for the 2020-2021 School Year

Motion: Trustee Edmonds moved to approve the revision to the Superintendent's contract for the 2020-2021 school year, as presented. Seconded by Trustee Herrera and carried with a roll call vote of 4:1 as Trustee Davis was absent.

- The Superintendent's title, remove "interim", is the only revision at this time. All terms in the contract will remain as is.
- District attorneys affirmed this item could be considered at a special board meeting.

7. STAFF REPORTS

A. Special Populations in Distance Learning

Staff reported on the progress of students in special populations during the first quarter of Distance Learning. Next best steps to iprove achievement for students in special populations were also discussed.

- Dr. McCoy gave a special shout out to the site attendance clerks, district office
 attendance staff: Margaret Clark, Sheila Fudge, Clara Galvez and all of the Learning
 Support Services staff for making the attendance system as user friendly, for teachers
 and students, as possible.
- Trustees were excited to see that home visits will be taking place. When sites begin their home visits they will follow the current RMHS model.
- The District will offer a one-stop website, linked to each school site's website, for student/family needs.
- There is a plan to have a mental health one-stop website as well. A grant will be considered at the December 16th Board meeting, along with additional information.

B. Public Information Officer (PIO)

Staff reported on the current approach to public information in the District and different approaches for future possibilities.

- The expectation for this position is to allow the director to have an oversight role instead of a hands on roll in terms of running social media, creating content, running the content and directly responding to the community through social media.
- The Web and Multimedia Coordinator position is absolutely critical and would remain.
- No director position will be added, given the research, but Dr. McCoy recommended
 that Trustees continue to discuss the consideration of option three: addition of a
 complimentary classified position to the Web and Multimedia Coordinator. If this
 direction is taken then the district will have the option of not renewing services with
 outside providers.
