B. Consideration of Approval of the 2018 Facilities Master Plan - Project List

PMSM Architects has engaged the Oxnard Union High School District community and its stakeholders in the facilities master planning process since October. During this process, the list of high priority capital projects has been prioritized based on (1) Fire, Life, and Safety (*Must Do's*); (2) Modernization Projects (*Need to Do's*); and (3) Other High Priority Projects (*Want to Do's*) identified by stakeholders. On February 28, 2018, the District held a Facilities Workshop and pursuant to the Board's request, District staff is bringing forward the 2018 Measure A – Facilities Project List as the recommended projects for the District and an allocation summary detailing how Measure A funds will be used.

Trustees confirmed that New Oxnard Area HS #8 is the number one priority expense for Measure A funding. Trustees were concerned about the order of priority for projects listed for each school site and making sure the list is revised for public clarity, the maintenance needs for the fields if astro turf is installed at district sites and which sites will receive it, completion of window coverings at school sites, site door lock-blok retrofit and the completion date of installation, allocation of funding per site for the facility needs project list, air conditioning at all sites, pool deck replacement and upgrades at OHS, what's included within modernization allowable expenses, and the management of the bond.

Motion: Trustee Herrera moved to approve the 2018 Facilities Master Plan - Project List, as presented with the caveat to be very transparent on priorities adding narrative to note that the priority of projects is not in the ordered listed on the presentation to Trustees and the public and HVAC projects as a priority at all sites in a timely manner. Seconded by Trustee Sher and carried unanimously. Vote 5/0

President Davis requested a break at 8:48p.m. and the meeting reconvened at 8:57p.m.

C. Consideration of Approval of Renewal Memorandum of Understanding between Oxnard Union High School District and Vista Real Public Charter - 2018 Summer School

California Education Code allows Charter Schools to collect ADA for student attendance in Summer Programs. However, the California Education Code does not permit traditional school Districts to collect ADA for Summer Programs. In Summer 2017, to improve and enhance Summer School, the District partnered with the Charter Management Organization Learn 4 Life to fund the District's Summer School Program. This partnership resulted in a larger summer school with a full reimbursement of the District's summer school expenses and a revenue stream of \$583,000 dollars. Following a review and analysis of Summer School 2017 District Administration recommended a renewal of the partnership with Learn 4 Life for Summer School 2018. This partnership will provide improved and enhanced Summer School opportunities for District students and will consist of District coursework, District Teachers, District Students, and District Facilities – with a guarantee of no recruitment by Learn 4 Life of students into their school year program.

Trustees asked if there will be a homework policy. Dr. McCoy replied there is no homework policy in place. Trustees asked what course the credit recovery applies to and Dr. McCoy replied that it applies to any course. Trustees expressed concern for the type of articulation that applies around students with mental health concerns, Special Education courses and credit recovery.

Motion: Trustee Sher moved to approve the renewal memorandum of understanding between Oxnard Union High School District and Vista Real Public Charter - 2018 Summer School, as presented. Seconded by Trustee Hall and carried by a roll call vote of 3/2; Herrera – No, Sher – Yes, Davis – Yes, Hall – Yes, Edmonds – No.

D. Consideration of Approval of the Second Interim, Fiscal Year 2017-2018

*Approved*

Education Code sections 42130 and 42131, as amended by AB 1200, requires district superintendents to prepare and submit interim financial reports to the governing board so they can certify to the County Superintendent of Schools the district's ability to meet its financial obligations for the current and two subsequent fiscal years. The 2017-18 Second Interim Report includes budget activity in the District through January 31, 2018. Administration reviewed the Second Interim Report for 2017-18 and presented the District's Multi-Year Projection for financial planning.

Trustees requested to have a line item under the revenue to note the summer school revenue received. Trustees requested a report to show what was done to reduce the structural deficit.

Motion: Trustee Herrera moved to approve the Second Interim, Fiscal Year 2017-2018, as presented. Seconded by Trustee Hall and carried unanimously. Vote 5/0

E. Consideration of Adoption of Resolution #18-09 Urging the State of California and Congress to Provide Funding and Implement Measures that Prioritize Student Safety

The safety and security of the students and staff of the Oxnard Union High School District is of highest priority to the Board of Trustees. Student safety is a prerequisite for consistently high levels of academic and social development. Resolution #18-09 urges the State of California and the United States Congress to take specific action to provide funding and implement measures to ensure all students and staff everywhere are safe and secure when they attend our nation's public schools.

Motion: Trustee Hall moved to adopt Resolution #18-09 urging the State of California and Congress to provide Funding and Implement Measures that Prioritize Student Safety. Seconded by Trustee Sher and carried unanimously. Vote 5/0

Public schools are charged not only with supporting student achievement, but also providing a foundation for mental and physical health, personal growth and civic engagement. Board Policy 0450 acknowledges that Oxnard Union High School District students and staff have the right to a safe and secure campus where they are free from physical and psychological harm. This Board Policy updates BP 0450 and recognizes the District's commitment to maximizing school safety and to creating a positive learning environment that includes strategies for violence prevention and high expectations for student conduct, responsible behavior, and respect for others.

Revision of *Board Policy 1250, School Visitors/Outsiders*. Oxnard Union High School District recognizes students and staff have the right to a safe and secure campus where they are free from physical and psychological harm. Oxnard Union High School District also believes that it is important for parents/guardians and community members to take an active interest in the issues affecting district schools and students. The Superintendent or designee will establish procedures which facilitate visits during regular school days and minimize interruptions to the instructional program.

**H. Consideration of Approval to Solicit Bids from Qualified Firms for the 2018 OUHSD Safety and Security Enhancement, Replacement and Improvement Projects**

*Approved*

The safety and security of the students and staff of the Oxnard Union High School District is of highest priority to the Board of Trustees. Student safety is a prerequisite for consistently high levels of academic and social development. District staff requested the Board of Trustees take immediate action to solicit bids from qualified firms to construct and implement security and safety measures that ensure the safety of our students and staff.

Trustees inquired about the capacity of the camera systems that will be purchased and if police departments can access these systems off site, training of personnel for the camera systems, what type of fencing will be purchased, the description of the communication systems to be installed, the importance of PA systems being able to be heard throughout each school site, a description of additional security measures being taken and what funding will cover the costs for these projects. Trustees requested that decisions made for purchasing safety items be thought through very carefully, no hasty decisions, and that safety items job completions be brought to Trustees at a Board meeting so all will be made aware, including the public, the completion of each item.

Motion: Trustee Sher moved to approve the solicitation of bids form qualified firms for the 2018 OUHSD safety and security enhancement, replacement and improvement projects, as presented. Seconded by Trustee Herrera and carried unanimously. Vote 5/0

**I. Consideration of Adoption of Resolution #18-08, Recognizing March 31, 2018, as César Chávez Day**

On César Chávez Day, we celebrate one of America's greatest champions for social justice. Born and Raised as a migrant farm worker, Cesar Chavez toiled alongside men, women, and children who performed daily, backbreaking labor for little pay in deplorable conditions. At the time migrant farmworkers were exposed to dangerous pesticides and denied the most basic protections, including minimum wage, health care, and access to drinking water. César Chávez devoted his life to correcting these injustices, to reminding us that every job has dignity, every life has value, and everyone -- no matter who you are, what you look like, or where you come from -- should have the chance to work toward their dreams. OUHSD recognizes the contributions and accomplishments of César Chávez to the community, State and nation.

Trustee Hall moved to adopt Resolution #18-08, recognizing March 31, 2018, as César Chávez Day. Seconded by Trustee Herrera and carried unanimously. Vote 5/0

**J. Consideration of Approval of Revised Board Policy 6115 Ceremonies and Observances [First Reading]**

She is currently in the Distance Learning Master's Degree Program in Communication Disorders & Sciences at California State University, Northridge and has been granted admission to the Speech-Language Pathology Services Credential Program for the Fall 2018 semester. The District is requesting the Commission grant a waiver for Professional Preparation Program for the Speech-Language Pathology Services Credential.


