6. RECONVENE IN PUBLIC/REPORT OF CLOSED SESSION ACTION The Board reconvened at 6:33 p.m. President Jáquez announced that during closed session:

- On motion by Trustee Alamillo, seconded by Trustee López Hanson, the Board of Trustees of the Oxnard Union High School District, approved the appointment of Clara Ortiz, Assistant Principal; motion carried unanimously.
- On motion by Trustee Edmonds, seconded by Trustee Alamillo, the Board of Trustees of the Oxnard Union High School District, approved the appointment of Elisa Rose, Assistant Principal; motion carried unanimously.
- > On motion by Trustee Alamillo, seconded by Trustee Edmonds, the Board of Trustees of the Oxnard Union High School District, approved the appointment of Jim Rose, Assistant Principal; motion carried unanimously.

7. PUBLIC COMMENTS: City of Oxnard Fire Marshall addressed the Board to speak about safety issues and protocols for graduation services. He requested that the Board and administrative staff work with the Fire Department to ensure that the bleacher seating capacity be kept to capacity limit and that all stair wells and entry and exit areas be kept clear. The Fire Marshall informed the Board that this information was discussed with administrative staff in April.

Oxnard Police Department District Liaison Officer piggy-backed on the safety protocol for graduation services. He stated the dialog began approximately two weeks ago at the May 14th Superintendent's Cabinet meeting; he reiterated that all exits and walkways be kept clear to ensure the public's safety, and mobility, in case of an emergency.

The Superintendent assured the Board that the District is working with Oxnard Police Department and Fire Department, and the Ventura County Sheriff's Department to ensure that the schools are following the recommendations presented by law enforcement and fire department agencies.

Trustee John Alamillo addressed the Board, as a parent, to state that he is aware of the safety issues regarding graduation services. He clarified that graduation tickets will be issued for sitting on the bleachers and that there is <u>no</u> limit to the number of people coming into the graduation ceremony. He opined that by limiting the seating in the bleacher areas this will allow the District to have more control over the crown and thus, be more enjoyable for the parents and guests.

A speaker expressed concerns regarding the late notification of the limited seating available for graduation services at Oxnard High School.

A speaker expressed concerns regarding the late notice parents received regarding the limited seating for graduation services at Rio Mesa and the poor communication with Board of Trustees.

A speaker expressed concerns regarding last-minute notification of limiting the number of seats at the graduation services at Oxnard High School, and commended the school for providing overflow seating arrangements in the school's performing arts center.

PUBLIC COMMENTS:

A speaker expressed concerns regarding the District's violation of the Brown Act and suggested that the Board allow the public to know about public business in a timely manner. The speaker stated that the District was doing its best to address the safety issues regarding graduation.

A speaker stated that seniors were not given enough notice regarding the drastic changes to

this year's graduation services and that the Board side with the graduates and allow all guests to attend graduation services.

A speaker said that parents should have been informed earlier in the year about the changes in the graduation services.

A speaker said that the notice seniors and parents received about limiting the number of guests to graduation services was sent out to late in the year.

A speaker said he understood the District's concern regarding the safety issues for the graduation services, but stated parents should have been informed about the changes earlier in the year.

A speaker asked what decisions the Board had made to come to the conclusion of requiring tickets at graduation events and asked if the District will start limiting all events in the future.

A speaker suggested solutions to resolve the overcrowding at graduation services and asked that the Board reverse the decision to limit the number of tickets available for graduation.

A speaker suggested that additional bleachers be brought in to accommodate all guests and asked for the Board's support on this special day.

Superintendent Soumakian clarified that the District was asked on May 14 to put a safety plan into effect for the graduation ceremonies and at no time did he say that parents and family would not be allowed to the ceremonies. He stressed that it is important for the safety of all parents and students that the schools have a safe, orderly ceremony and reported additional seating arrangements are in the works.

A speaker expressed concerns about the placement of the Community Day School.

A speaker asked the Board to work together with community groups and labor unions and pull all resources together to make a difference in this year's election.

A representative from OFTSE provided an update on labor negotiations, expressed concerns about the District's budget and asked that the District continue to work with the Union.

A speaker expressed concern with the closure of the English classes offered at Pacifica High School through the adult school program.

A speaker said the District is not listening to the needs of the teachers and not putting students first, to consider the impact the classified layoffs will have on the schools, to reinstate the days that were cut from the calendar, and technology is not a priority — WIFI does not teach our students.

A speaker opined that the expenditure of WIFI service will not make our students smarter; it will require teachers to monitor students closer instead of focusing on teaching.

A speaker said kids need to be in school not out of it, listen to what the teachers want, listen to the motto "put students first", get input from staff, and be more transparent.

A speaker expressed concerns regarding the District's adult transition program, the Brown Act violations, and asked the Board to be honest, transparent and have open communication.

A speaker was concerned that the post-secondary program was being moved to accommodate the community day school and asked the Board to consider the impact changes have on students, and opined the Board was in violation of the Brown Act.

President Jáquez clarified that tonight's special meeting is not a violation of the Brown Act, that legal counsel was contacted prior to posting the agenda, and that all information on the regular agenda is on tonight's agenda.

PUBLIC COMMENTS:

A representative from OFTSE reported that the Union is concerned that the Board is not listening to the needs of the students and staff; the speaker expressed concerns that a vacancy posting was distributed without the District receiving input from Union members, and asked that the Board do what is best for students and the community.

A speaker spoke in support of all the classified employees of the District.

In appreciation for his service as the 2011-2012 Student Representative to the Board, President Jáquez presented Daniel Galang, a certificate of achievement and Daniel's Student Representative and ASB President picture. On behalf of the Board, President Jáquez thanked

Daniel for doing a great job and wished him well.

C. Regular Report:

Student Representative to the Board of Trustees

Daniel stated it was an honor participating in the Board meetings; he found the board reports interesting and is exciting about the new high school sites coming up in a few years; he thanked the Board for allowing him to attend the CSBA conference and said he feels he will be leaving the District a more mature person.

Daniel reported that all schools are closing out the year with end-of-year activities for such as Senior breakfast and Grad night, and conducting installations for next year's officers. Daniel announced that next year's Student Representative to the Board is Stephanie Pinedo, from Adolfo Camarillo High School. Daniel agreed with the speakers and stated that seniors should have been advised earlier in the year about the changes to grad ceremonies, and seating should be available for all family members so that they can see their graduate go through the ceremony.

D. Board Update:

Superintendent Soumakian reported:

New School Sites:

Measure H Bond monies cannot be used to pay employee salaries and must be used solely for

construction of new schools.

City of Camarillo Town Hall Meeting:

The meeting was well-attended by members of the community, LAFCo, and Camarillo City Council representatives and it was the perfect opportunity for the community to voice their concerns and opinions.

Graduation Services:

Additional seating for graduation will be available at all the schools to accommodate all guests and notification from Fire Marshall was received on May 14 that a Safety Plan would need to be developed for graduation services or the services would be closed down.

CIHS Auto Shop:

Dedication Ceremonies for the new Transportation Academy were held at Channel Islands. Dr. Soumakian clarified that the renovations were funded by grant money, not general fund money.

State Budget:

Dr. Soumakian said the budget literally changes every week, the District cannot control the money coming into the District, but it can control the expenditures. It is in the best interest of all that the community and the District work together to ensure that the Tax Initiatives pass.

State Budget Update:

Dr. Barry Schimmel reported the information from School Services of California on the State's budget and economy has not improved and remains the same. The District is spending more money than what it is receiving and must have a 3% reserve by June 30. Dr. Schimmel provided examples of where one-time monies could be pulled and explained that ERate money can only be used for infrastructure improvements and is geared toward technology use and by law cannot be used as operating revenue to pay expenses.

A speaker stated that under the Brown Act a public speaker may address any item on the agenda, and requested that handouts of the Budget presentation be made available for the public.

Trustee Alamillo moved to approve the Consent Calendar Items as amended, item 9-A and I were pulled for discussion.

A speaker addressed concerns regarding Consent Item 9-G; the speaker opined the District is not receiving a level of customer service, offered by this company (Josten's), that is up to par and expressed concerns with not getting the best product available for students.

Trustee Alamillo requested that Item 9-A be rebid and brought back at a future meeting and he thanked Jess and Laura Borjon, David Arroyo, Heriberto Rojo, and Steven Reyes for their donations to the District.

Trustee Alamillo moved to approve the agenda as amended, item 9- A was removed and item 9-I was returned to the agenda, seconded by Trustee Stocks; motion carried unanimously.

11. BOARD MEMBERS' REPORTS AND COMMUNICATIONS

Trustee Stocks reported attending the Hochlander Connect Ed session and found it very informative and the dedication services at CIHS and was impressed with the new auto shop. He suggested moving additional bleachers to accommodate the graduation guests.

Trustee Edmonds thanked the public for expressing their concerns and appreciates the comments made. He asked that additional seating arrangements be explored for guests and suggested starting early next year with graduation notices.

11. BOARD MEMBERS' REPORTS AND COMMUNICATIONS-Continued

Trustee Alamillo agreed that a short notice was given to families regarding graduation services, but the process to limit the seating has to start somewhere and things will eventually work out. He stated that the \$6million cannot be used for salaries and there is a lot of misinformation that is meant to do one thing and that is to distract from the real information. He remarked that the District is trying to be forthright, that there is no money, and the District is not hiding any. Regarding the state of the District's budget, Trustee Alamillo expressed concern that a teacher's comment regarding expenditure of WiFi money is inaccurate and stated "it is the responsibility we have at the dais to make sure that our house is in order and make sure our numbers match. It is really insulting to say we don't like kids and don't consider education first."

Trustee López Hanson piggy-backed on what had been said, and said she felt insulted that she was called a liar at the Camarillo Town Hall meeting and at tonight's meeting. She stated "I truly and sincerely believe that the Board can make a difference in children's lives. The decisions made here are not the easiest and before making a decision consider what is best for the child. If comfortable with that decision, will approve to move forward. At the Town Hall meeting, the Mayor called the District a liar, here tonight we are called liars. It was wrong for him to do that and for others to call us liars. We are trying to make the best of a terrible situation. I don't want' to be the Trustee that closes the door and I sincerely hope that doesn't happen. This Board has tried valiantly to do what is best. Those with whom I speak, and those whom I trust, and then those that call me a liar, lose my sport."

President Jáquez stated "I too do not like to be called a liar and I will defend myself. I consider myself lucky to serve because I have helped many, many youngsters in this area. For someone to say that I have not been in the trenches and haven't helped kids is not an honest thing to say. I live on my integrity and if I make mistakes, I will admit to them. This Board is not out to hurt anyone. The District is at our wits end with this budget situation and we are not withholding money. That is a very, very ambitious statement to make when our teachers are very well-paid and it is that way because of the people on this Board. To say that we are trying to get into their pocket-book is funny, and to call that on my integrity, I will defend that also.

Superintendent Soumakian clarified that based on the recommendations made by the Board additional seating will be available for the graduation services at all the sites so that guests will be able to watch a very dignified celebration.

A speaker stated in protest to the District's decision to continue with ticketing graduation his children will be kept home on Friday and June 1, and urged the Board to reverse their decision.

A student thanked the Board for their time and asked for collaboration with seating arrangements.

A representative from the Union said there is miscommunication out there that is misleading and would like to work together so that everyone is on the same page and be allowed to give input.

Trustee López Hanson stated we do hold public meetings, we don't withhold anything. The information is there, but people choose not to avail themselves of this information.

Trustee Alamillo stated that he wanted to move forward in a positive way with everyone working together to get this done. He clarified that "this is a meeting of the Board in public, not a public meeting...It is inappropriate for the public to interrupt our dialog with speaker cards on every item." Trustee Alamillo requested that clarification be provided on speaker card process.

President Jáquez said he considered this an open meeting for people to talk and there is some direction from the Brown Act and that is why he allows the public to talk out of sequence.
