**RECONVENE IN PUBLIC:  
REPORT OF CLOSED SESSION  
ACTION:**

The Board reconvened at 6:50 p.m. President López Hanson stated under closed session item Student Personnel [Education Code §35146, 48912, 48919] the Board upheld the recommendation of the Administrative Panel, and under closed session item Public Employee Discipline/Dismissal/Release/Appointment [Government Code Section 54957] approved the recommendation of administrative staff.

**AUDIENCE TO ADDRESS THE  
BOARD OF TRUSTEES:**

A district employee addressed the Board to request back-pay for salary and benefits.

A representative from CRLA addressed the Board to express concerns regarding the District's discipline policies and stated current policies may have resulted in a practice of discrimination against students impacted by these policies. The representative stated student discipline is not just a district issue, but also a community issue.

Trustee Jaquez stated the District needs to look at where our students are being placed, and the District needs to look at why our students are missing school.

OFT President stated it is the opinion of the majority of OFT's Executive Board that district counsel, Mr. Jackson Parham's contract not be terminated. OFT President stated Mr. Parham has for the past two decades worked well with the Union in contract negotiations and labor disputes, he is fair-minded, and has a wide-range of background in educational issues.

A speaker thanked the Board for the improvements to the District's website design, and supported the recommendation made by LULAC to suspend credit card usage by District administrators.

Oscar Hernandez, Principal of Hueneme High School provided an update on the process conducted for selecting a company for the purchase of student graduation caps and gowns, and school rings. **BOARD MEMBERS' REPORTS AND COMMUNICATIONS:**

Trustee Stocks expressed concerns regarding the number of additional Board meetings. He stated this is causing an increased work load for district office staff, and requested that in March the Board revert back to one Board meeting per month.

Trustee López Hanson suggested going back to the electronic Board Book, which will ease up on workload, time and expense, and decrease delivery of information to Trustees' homes, wear and tear on machines, and reduce paper waste.

Trustee Alamillo inquired where money from the vending machines was going, and if there was an accounting procedure by schools. He suggested holding Board workshops, which would be less burdensome for staff, have roundtable discussions and delve more deeply into issues. He suggested that the Board direct the superintendent to grant OFT access to use of global email system.

Trustee Jáquez attended the Pre Engineering and Law Enforcement graduation services, he spoke with Fran Pavley in reference to several issues, he met three times with CRLA, and he attended the Black Caucus Session in Fresno. He requested that the Board evaluate the superintendent, review Board Policies, and attendance at Board Meetings by Trustees.

Trustee López Hanson stated she was honored and pleased that she was asked to help hold the banner for Martin Luther King Holiday. She reported she had received a second letter from the Ventura Grand Jury requesting data from the District. She reported attending several meetings with attorneys regarding the food services program.

Trustee Edmonds asked that the Board restore global email access to OFTSE. He stated that there are certain issues throughout the year that must meet certain timelines and would prefer that there be two Board meetings per month. He expressed concerns about the conditions of the outdoor basketball courts at CIHS and RMHS. The courts are in disrepair, rims are bent and some have no netting, and the asphalt areas could use resurfacing. Lastly, he stated our students deserve better facilities.

Trustee López Hanson added her vote to restore global email service to OFTSE.
