## 11. SUPERINTENDENT'S REPORTS:

11-A Regular Report: School Site
Student Activities

Daniel T. Galang, Student Representative to the Board of Trustees reported on various student activities such as Homecoming activities, fundraisers and food drives. He stated OHS held a winter ball; ACHS students took a trip to Catalina Islands; and at the recent ODC meeting, the CIHS representative reported that students and parents will be starting a fundraiser to build a swimming pool at the school. In closing, Daniel said he had a great time at the CSBA conference; he enjoyed the social networking with peers and thanked Trustees for allowing him to attend the conference.

11-B Board Update: Nutrition Services

Kevin Dicey, Nutrition Consultant and Chad Williams, District Manager, via a PowerPoint presentation provided a progress report on the District's nutritional services department. Mr. Dicey stated Sodexo is focused to make every day a better day for students. He reported that in order to provide healthier choices and a greater selection, the menu changes every 6-8 weeks; the menu features daily specials and home style cooking; the district has partnered with local Ventura County farm/produce vendors to purchase fruits and vegetables; and, local grown fruits and vegetables are featured monthly. He said sales during the months of September and October were up 4.6% based on same time last year and the District has the lowest lunch prices in Ventura County. He was pleased to report that Sodexo continues to partner with student and parent groups and in the future an on-line survey will be available so that students and the community can submit their input. In closing, he stated the food services department provides service to six high schools, one charter school, one continuation school, and employees approximately 150 food services workers.

11-C Board Update: 
➤ Solar Projects

Stephen McFarland, Director of Maintenance, Operations, and Facilities presented updates on the District's solar and swimming pool projects.

Performance monitoring and profile on the SunPower Solar projects:

- ➤ OHS received SCE permission to begin operating on September 29, 2011 and to date the estimated cost savings is \$33,948; emissions of carbon dioxide have been reduced by over 146 tons
- ➤ RMHS construction is nearly complete, SCE inspections are scheduled for December 19, 2001 and will be energized after receiving SCE permission to operate by early 2012
- ➤ PHS construction will be in full swing during winter break with final completion estimated at April 20, 2012
- via SunPower, CIHS received DSA approval on November 30, 2011 and is currently preparing subcontractor bid packages, final completion is estimated at May 25, 2012
- ACHS received DSA approval on December 2, 2011 and is currently preparing subcontractor bid packages, final completions is estimated at May 25, 2012.

- 11-D Board Report: Graduation Rate

William E. Dabbs, Assistant Superintendent-Educational Services reported the California Department of Education in cooperation with the National Department of Education has developed a new method for determining graduation rates. The new cohort graduation rate will now serve as a baseline in 2011 and should be compared to rates from previous years. Mr. Dabbs said the District's graduation rate increased by 9.1%, the Hispanic graduation rate by 12.1%, and our Afro-American rate increased by 20%.

- 11-E Board Report: Learning/Program Improvement
- Pivot William E. Dabbs, Assistant Superintendent-Educational Services stated Pivot learning is providing support to the District by acting in the capacity of outside support provider as required by Year 3 PI and with the assistance of Dr. Mary McGee, the District is ensuring that we are in compliance with the CDE in responding to progress on our LEA Plan. Walkthroughs have been conducted in classrooms in each of our high schools. Pivot has facilitated principals in identifying the highest priority recommendations from the LEA Plan and has provided mentors to administrative staff in Human Resources, Educational Services, and Student Testing and Administration. Currently, a review is being conducted to primarily look at academic issues of the District's Special Education department.
- 11-F Board Report: Enrollment and Attendance

Jennifer Haney, Administrator of Student Services and Roxanne Pirayesh, Attendance Consulting Manager from School Services Innovations and Advocacy presented a report on the District's student enrollment and attendance rates. It was reported the District is working with School Services Innovations and Advocacy to improve our attendance program and ADA throughout the district. Steps have been taken to improve the District's ADA such as phone calls and letters to parents and home visits by Attendance Advisors. ADA has increased district wide over the last two years in the comprehensive high schools and continuation school, and the district is no longer in declining enrollment. Mr. Dabbs stated the district does not receive funding from the state based on enrollment, only on the number of students who actually attend each day.
