6. **AUDIENCE TO ADDRESS THE BOARD OF TRUSTEES-continued:** Mr. Steve Ornelas, Oxnard Adult Baseball representative, asked the Board to consider allowing the adult baseball programs use of the high school district's baseball fields. Mr. Ornelas stated the program would be willing to donate money to the schools in exchange for use of the baseball fields.

7. **SUPERINTENDENT'S REPORTS:**
- 7-A Report: Student Career Plans Assistant Superintendent Mutz introduced Directors Phyllis Throckmorton, Director of Career and Technical Education and Ms. Rebecca Buettner, Director of Assessment and Accountability who presented the District's Student Career Plan via a PowerPoint presentation. Facts presented: one-third students finish high school but lack the academic and technical readiness to succeed in college or a career; CTE teachers are developing programs for individual career pathways for students; and incoming 9th graders are having issues with the transition to high school. This year, the CTE Plan will address obstacles facing students by assessing all 9th graders during second semester. The COIN Assessment will be administered to all incoming 9th graders (2010-11) and Counselors will review findings and make course adjustments where needed. On behalf of the Board, President Valles thanked Ms. Throckmorton and Ms. Buettner for a very thorough report.
- 7-B Update: Facilities Master Plan Via a PowerPoint presentation, Mr. Randy Winton, Assistant Superintendent-Business Services and Mr. Stephen McFarland, Director of Maintenance Operations provided an update on the District's Facilities Master Plan. Thirty-eight projects were highlighted: at ACHS the Agricultural Greenhouse, performing arts facility, and swimming pool. The HHS Child Development Center, bleachers and security fence. The OHS Woodshop expansion. The solar voltaic fields at OHS and RMHS. The architect plans for new high school. Various housekeeping projects at all the sites. And, possible relocation of the District Office. On behalf of the Board, President Valles thanked Mr. Winton and Mr. McFarland for a very thorough report.
- 7-C Regular Report: Bryant Jones, Student Representative to the Board of Trustees, thanked Trustees for the opportunity to attend the CSBA Annual Conference in San Diego. He enjoyed being able to attend the various workshops offered and meeting student representatives from throughout the state. Trustee Jáquez attend the law academy graduation, the district staff breakfast, and a meeting at El Concilio. He suggested starting the Board meetings at 6:30 p.m, if there are no closed session items. He was pleased to hear that all vacant positions in the district would be advertised.

Dr. Carter stated that all vacant positions would be advertised to afford everyone an equal opportunity for employment – the District is a equal opportunity employer.

Trustee Stocks attended several student athletic events. He asked administrative staff to summarize the Board Policy for Field Trips and produce a one page summary of the policy for the schools to follow.

Trustee López Hanson attended a forum on housing issues at the Ventura County Star. The focus was on the impact the housing situation will have on transportation. The issue of partnership between transit systems and the schools was discussed and the response was this is not likely to happen because of the hours students would need the service, which would create a down-time. Lastly, she received an invitation to participate as a judge for the Annual Migrant Education Speech and Debate tournament.

Trustee Valles shared he had the same concerns about transportation and stated other cities have partnerships with schools districts. He has discussed this with city officials and stated this is doable.


