#### SUPERINTENDENT'S REPORTS:

- Board Update:** Oxnard High School and Channel Islands High School Mock Trial Teams  
Superintendent Carter reminded Trustees that Oxnard High School will participate in the Academic Decathlon and Mock Trial competition at the state level. He reported that the teams will be recognized at a special meeting on April 21 at 6:30 p.m.
- Board Presentation:** Drop-out Report  
Director of Assessment and Accountability Rebecca Buettner presented a summary of the 2008-2009 Dropout Report via a PowerPoint presentation. She reported there were fewer dropouts for 2008-09 (483) vs 2007-2008 school year. The rate has been improving each year, of those 483 - 390 were twelfth graders, and Pacifica reported the highest number of drop-outs over a five-year period. Total district enrollment for the year was 16,476.
- Progress Report:** Facilities Master Plan  
Via a PowerPoint presentation, Assistant Superintendent-Educational Services Randy Winton and Director of Maintenance, Operations and Transportation Stephen McFarland highlighted areas of the Facilities Master Plan that have been completed, or are near completion.
- Regular Report:** Student Representative to the Board of Trustees  
Bryant Jones reported Pacifica High School reached the second round of CIF in the basketball playoffs and stated he was especially proud of the coach and team. ASB presidents met on March 17 and discussed concerns expressed by students throughout the district regarding the poor food service provided by cafeterias. He reported on several end-of year student activities and athletic events. He spoke on behalf of the district's counselors and asked Trustees to consider not reducing the number of counselors and he thanked his counselor for the support she provided him during his four years at PHS.

*Denied*

Ms. Mutz described administrative staff's three areas of concern 1) special education, 2) facilities, and 3) grade levels. Areas one and two can be easily addressed, area three is more difficult. Within five years, Summit would enroll ninth grade students. At the end of those five years no data would be available to evaluate the worthiness of the high school program. Ms. Mutz stated the recommendation from staff is that the evidence is not clear that Summit would be successful and staff prepared a resolution should Trustees choose to deny the Charter due to grade levels. Trustees expressed concerns regarding the lack of data available to back up anything for the high school level and nothing to substantiate the district moving forward for an additional five years.

Based upon the recommendation of administrative staff that Summit Charter would not meet the needs of grades 9-12, within the five-year period, Trustee Stocks moved to deny the charter based on the grade levels served and approve the Resolution, seconded by Trustee Benfield; motion carried unanimously.
