SUPERINTENDENT'S REPORTS:

Board Report: 2009-2010 Accomplishments – Phase II, Division Heads, Board's High Priorities List and Other Dr. Carter presented the 2009-2010 Accomplishments of each division, and the progress being made on the Board's High Priorities List. He reviewed the top five high priorities and honorable mention, and stated the information will be posted on the district's website.

Board Update: Regarding OUHSD Measure H Bond Oversight Committee Dr. Carter reported all but two members of the Measure H Oversight Committee agreed to serve on the committee.
