**AUDIENCE TO ADDRESS THE BOARD OF TRUSTEES:**

Mr. Joe I. Mendoza, Ventura County Office of Education Migrant Education Program, on behalf of the VCOE, expressed appreciation to the Board for allowing the County Migrant Program to use the Oxnard High School facilities to host the Annual Migrant Education Speech and Debate Tournament. Over 900 students participated this year – the largest in the history of the tournament. Mr. Mendoza thanked and recognized Trustee Valles who served as a judge at the debate, and presented a plaque as a small token of esteemed appreciation. Mrs. Lupe Reyes Castillo presented a plaque to the Board in appreciation for outstanding support of the Migrant Education Speech and Debate Tournament.

Board Recognition: *Pre-Engineering Program Awards*

Mrs. Phyllis Throckmorton, Director of Career and Technical Education was pleased to recognize the engineers and staff who have served as teachers in the Pre-Engineering Program at Port Hueneme. Since 1998 this partnership between the Oxnard Union High School District and the Port Hueneme Division Naval Surface Warfare Center have provided opportunities for over 500 OUHSD students to work directly with engineers at NAVSEA with hands-on experiences to explore the fields of electronic and mechanical engineering, and computer science. Captain Vern Foster, representing NAVSEA, thanked the District for their continued support. Letters of Appreciation were presented to the engineers by Capt. Foster and Trustee Valles.

Board Recognition: *Rio Mesa High School Knowledge Bowl Team*

Mrs. Martha Mutz, Assistant Superintendent-Educational Services was pleased to report that Rio Mesa High School placed first among district schools and third in the county in the 47th annual Knowledge Bowl competition. - Board Recognition: *Annual Art High School Exhibit* Mrs. Throckmorton announced the winners of the 18th Annual High School Art Exhibit. The event was hosted by the Ventura County Maritime Museum, at Channel Islands Harbor in Oxnard. All student art was on display at the Maritime Museum during April. Certificates of appreciation were presented to the First, Second and Third place winners by Trustee López Hanson and Mrs. Throckmorton. A plaque was presented to Rio Mesa and Hueneme high schools for placing first in each category.
- Board Recognition: *Music Contest Winner – Pacifica High School* Mrs. Throckmorton was pleased to report that Pacifica High School received first place at the District Music Festival held at Pacifica High School on March 20 and 21. In conjunction with the Southern California Band and Orchestra Association, Pacifica High School hosted 28 middle school and high school bands and string orchestra ensembles from Los Angeles, Ventura and Santa Barbara counties. Sister schools from the District also participated. This year, Pacifica High School Symphonic Band received an excellent rating for both their onstage and sight reading performances. Band Director Cathy Rogers introduced students and with the assistance of Dick Jáquez presented certificates of achievement. Trustee Jáquez presented a plaque to Pacifica High School for their accomplishments.

Mr. Jáquez attended the Destino Club luncheon where local students were recognized and awarded scholarships to local universities, and he attended several meetings where the topic of discussion was the upcoming propositions.

Mr. Stocks attended all open house events and the Rio Mesa/Oxnard Varsity Baseball game.

Mr. Valles commended the VCOE for a job well done presenting the Speech Debate Tournament that drew over 980 participants from throughout California, he attended the ACE committee meeting, and he met with Mr. Edwards and representatives from Sacramento regarding the Small Engine Class and emphasized the large move behind vocational programs and the importance of engaging our students in these types of programs.

Trustee Benefield shared that there is a perception from residents of Camarillo that they are firm believers that this Board is not interested in building a second high school in Camarillo. Trustees López Hanson and Jáquez have communicated very strongly that they would like an item placed on the agenda to start planning for a high school in Camarillo. It was her opinion that transactions were being conducted behind closed doors to select a superintendent and she did not respond to the memos because she felt it was inappropriate. It is her opinion that these actions are a violation of the Brown Act and will have a long term effect on the District.

Mr. Stocks responded that there has been no violation of the Brown Act. He worked with Nancy Serros to gather the information for the memos and did not speak to individual members of the Board.

Mr. Jáquez was pleased that the Board is moving forward on forming high school committees, he asked that the district's attorney look into restrictions placed by SOAR on properties selected for new high schools, and he expressed concerns regarding the closure of the Puente program.

At the request of Mr. Stocks, Mr. Winton provided information regarding the properties in Oxnard and Camarillo.



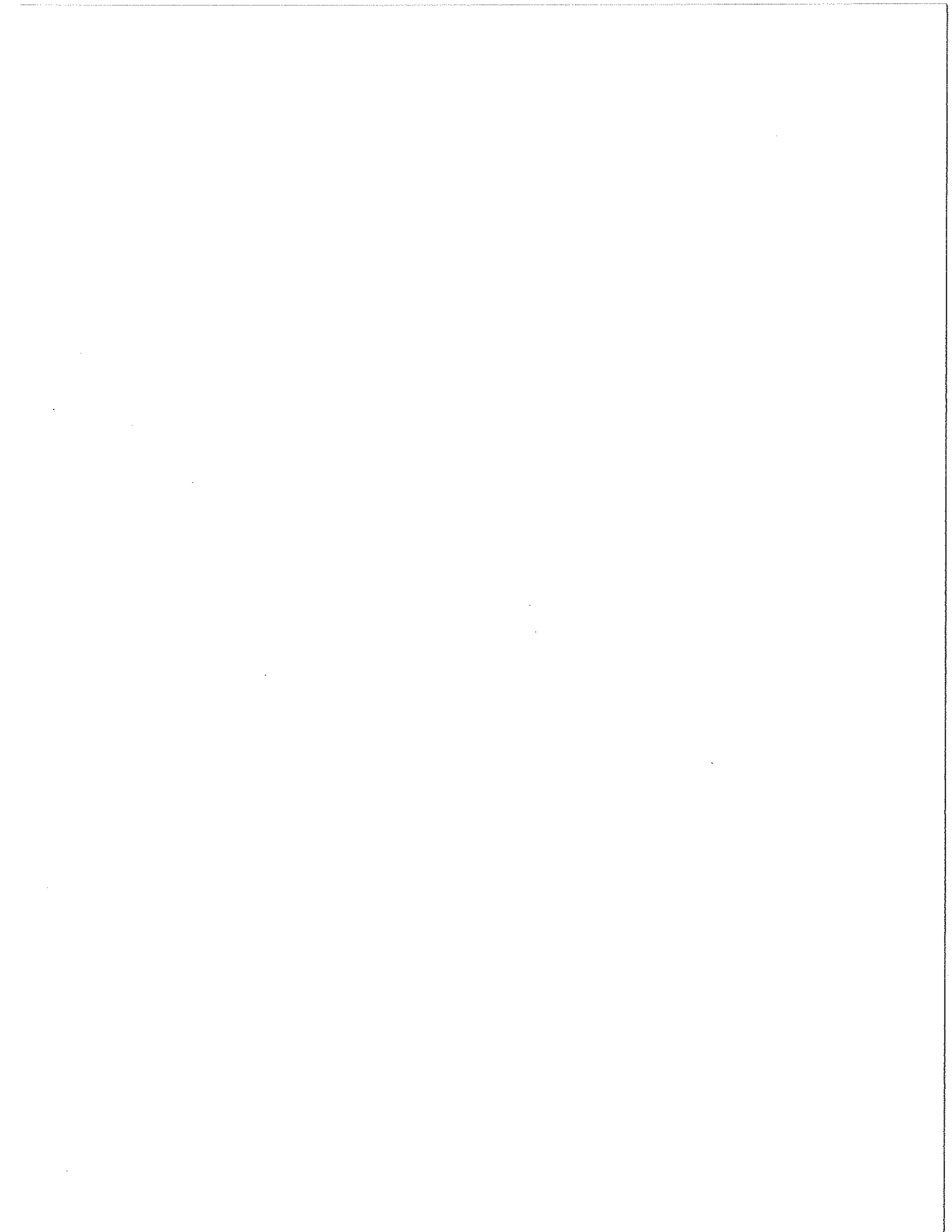
