7. **RECONVENE IN PUBLIC:** The Board reconvened in open session at 6:30 p.m. President Pinkard announced there was no action taken during closed session.
8. **AUDIENCE COMMENTS**
- Ms. Linda Zilisch, Rio Mesa High School parent.* Ms. Zilisch inquired if the Board had received her letter of concerns regarding Rio Mesa High School. Trustees acknowledged receipt of letter.
- Mr. Melvin Nunnery, Oxnard High School Head Girls' Basketball Coach.* Mr. Nunnery stated that he would like Trustees to reconsider the termination of former girls' basketball coach, Kenny Plummer. Mr. Nunnery spoke on behalf of Coach Plummer asking Trustees to look at his positive contributions and the effect his termination will have on the team. He stated he is an excellent role model and, to look at the *whole picture* and not just at the few complaints made against Kenny.
- Ms. Jennifer Gaines, Oxnard High School student.* Ms. Gaines spoke on behalf of the Oxnard High School girls' varsity basketball team. She informed Trustees the entire situation regarding Coach Plummer was completely taken out of context, to look at the great work he has accomplished with the program, and that he is a great man and coach.
- Mr. John Dunham, resident of Oxnard, daughter is a student/basketball player at Oxnard High School.* Mr. Dunham stated he is aware of what protocol and what standard educators and coaches have to look up to. His experience is that Kenny Plummer and the other coaches have been excellent examples, great leaders and at no time have expressed any type of inappropriate comments or behavior. Oxnard High has an excellent basketball program due to Coach Plummer's hard work, the team works well together, and Coach Plummer teaches the girls to be responsible for their actions. Mr. Dunham asked Trustees to reconsider Coach Plummer's release.
- Ms. Anna Rodriguez, sister of VI student Aziza Cano.* Ms. Rodriguez commented publicly on the well-written commentary published in the January 13 Sunday paper by Superintendent Dunlap, *OUHSD Addresses VI Students' Concerns*. Ms. Rodriguez stated several issues she had regarding the VI Program and asked Trustees to look at the lack of services provided to visually impaired students, specifically her sister.
- Ms. Aretha Vines, resident of Oxnard.* Ms. Vines spoke on behalf of the Oxnard High School girls' varsity basketball team. She reported she has seen a positive change at OHS with the coaching of Kenny Plummer. She asked Trustees to look at the real reason as to why he was let go.
- Ms. Gina Hudson, a concerned parent actively involved at OHS.* Ms. Hudson questioned the unfair release of Kenny Plummer stating he is an intelligent young man, a mentor and someone who motivates our kids to be the best they can be. She asked Trustees to please reconsider his release from the team and stated everyone deserves a second chance.
- Ms. Kendra Robinson, her daughter is a June graduate of Oxnard High and was on the girls' basketball team.* Ms. Robinson spoke on behalf of Kenny Plummer stating he is not only a coach and mentor; he also motivates the girls to do well in school so that they will be contributors to society. Ms. Robinson asked Trustees to reconsider the decision, look at the whole picture, and not ruin Kenny's life and the lives of those affected by his release.

9. SUPERINTENDENT'S REPORTS

9-A Annual Student Dropout Report:

Ms. Becky Buettner, Director of Assessment and Accountability, provided a PowerPoint presentation on the 2006-2007 Annual Student Retention/Drop-out Report. The total number of OUHSD dropouts for the 2006-2007 school year is 513, an increase from the previous year.

AUDIENCE COMMENTS

At this time in the meeting, President Pinkard informed Trustees she had a request from a member of the audience to address the Board. Upon the consensus of the Board, the request was granted.

Ms. Tina Felipe, sister of Aziza Cano. Ms. Felipe stated the article by Dr. Dunlap in *The Star* was very interesting and well put. She asked if the VI issues addressed in November had been resolved and asked for a report/audit showing the efforts made by Human Resources to obtain a VI teacher, she inquired if the CAHSEE results included special education students, and she asked Trustees to look *outside the box* and utilize the county's resources to help VI students.

Ms. Aziza Cano, VI student at OHS. Ms. Cano informed Trustees she had passed the CAHSEE this year and had previously failed the exam due to the lack of materials that were not provided at her request.

Mrs. Anna Rodriguez, mother of Aziza Cano. Mrs. Rodriguez stated that at the November Board of Trustees' meeting, President Jaquez had requested a full investigation regarding the VI program and asked if the report was presented to Trustees.

Trustee Jaquez reported Trustees had received information to the questions they had regarding the VI program from the Director of Special Education and Superintendent Dunlap. Trustee Jaquez stated that this was not part of the Agenda and he was answering the question for clarification purposes.

President Pinkard informed Mrs. Rodriguez, she and Superintendent Dunlap would meet with her to address her concerns. She stated the Visually Impaired program has improved dramatically and that Trustees would continue that effort to make sure that visually impaired, and all other students, get what they need to be successful in this district.

9-B General District Acknowledgements/Updates:

Superintendent Dunlap extended congratulations to Student Board Representative Seira Matsushima for the nice article in last week's *Star*; and piggybacked congratulations to every student, to parents, all of the staff members and site administration at RMHS for being awarded the International Baccalaureate Program that begins in the fall. She reminded Trustees Jack O'Connell will visit Oxnard High on Friday and be recognized during the half time activities; she reported final exams are next week and second semester starts on January 28.

She stated the District's bond is dissipating, has lost value and asked what plans the District has for the bond.

Assistant Superintendent Randy Winton stated the District has not sold any bonds. Trustee Stocks stated while waiting for Unification the bond has lost value and the District is losing out on money. Mr. Winton reported the District has lost \$40 to \$50 million in the last six months.

Trustee López Hanson requested an update on the Technology Department.

Trustee Jaquez requested an update on the Independent Study Program.

Trustee Valles requested a change of venue for the March 12 Board Meeting. Superintendent Dunlap stated she will inform Trustees of the change when a date is selected.




