

TRAVEL POLICY COVID-19

October 11, 2021

Barnhart School, in compliance with the Los Angeles County Department of Public Health Travel Advisory and Guidance, continues to follow the CDC travel guidelines should you choose to travel outside of California. In particular we ask:

- Do NOT travel if you are sick, you have a recent positive COVID-19 viral test result, or you are waiting for results of a COVID-19 viral test after being exposed to the virus.
- Delay travel until you are fully vaccinated.

Fully Vaccinated Persons

- Fully vaccinated persons may travel **domestically** without a pre- or post-travel test and without quarantining if they do not have symptoms of COVID-19 after domestic travel.
- Fully vaccinated persons may travel **internationally** provided they take additional precautions in compliance with <u>LACDPH</u> and <u>CDC</u> guidelines. Requirements include pre- and post-travel COVID-19 viral testing.

Unvaccinated Persons (Including students not eligible for vaccination)

If you are not fully vaccinated and must travel, take the following steps to protect yourself and others from COVID-19:

- Domestic Travel (United States, outside of California):
 - Before travel get tested with a viral test 1 -3 days before travel
 - After travel get tested with a viral test 3-5 days after travel AND stay home and self-quarantine for a full 7 days after travel.
- International Travel:
 - Before travel get tested with a viral test 1 -3 days before travel
 - Returning before you arrive in the United States: ALL air passengers are REQUIRED to have a negative COVID-19 viral test no more than 3 days before boarding a flight to the United States
 - After travel get tested with a viral test 3-5 days after travel AND stay home and self-quarantine for a full 7 days after travel.

Examples of Travel Dates for UNVACCINATED:

Families choosing to travel outside of California over the holidays with their unvaccinated children will need to follow a quarantine period. Students will not be able to return for in-person learning until they complete the quarantine period. See below:

Travel Outside of California Return Date	After-travel Viral Test Window (3-5 days after travel)	Eligible to Return to School for In-person learning (only with viral testing)
Sunday, November 21, 2021*	11/24/21 - 11/26/21	Monday, November 29, 2021
Friday, November 26, 2021	11/29/21 - 12/1/21	Monday, December 6, 2021
Sunday, November 28, 2021	12/1/21 - 12/3/21	Monday, December 6, 2021
Tuesday, December 28, 2021**	12/31/21 - 1/2/22	Wednesday, January 5, 2022
Sunday, January 2, 2022	1/5/22 - 1/7/22	Monday, January 10, 2022

*Thanksgiving Break: Saturday, November 20th - Sunday, November 28th. In order to return to in-person learning when school reopens after Thanksgiving Break on Monday, November 29, 2021, unvaccinated individuals must return to California no later than Sunday, November 21, 2021.

** Christmas/Winter Break: Friday, December 17th - Tuesday, January 4th. In order to return to in-person learning when school reopens on Wednesday, January 5, 2022, unvaccinated individuals must return to California no later than Tuesday, December 28, 2021.
