Years in Review

Dear Hausner Community,

This year we are presenting a combined 2-year annual report covering the 2019-20 and 2020-21 school years. And, what a two years it has been.

In March of 2020, Hausner closed its actual doors to in-person instruction. Within three days of closing our physical doors, Hausner opened its virtual doors and launched a highly successful distance learning program for students in all grades. Despite the significant challenges and uncertainty of the pandemic, Hausner teachers and staff were a beacon of hope and possibility. Our students continued to receive outstanding academics and a strong social-emotional program just when they needed it most.

The uncertainties continued into the summer and early fall, and once again the Hausner community rose to the challenge, obtaining a County waiver to reopen just a few weeks into the new school year. Reopening our physical doors was a critical milestone, one met with joy and excitement by staff, students, and parents.

Hausner took significant steps to protect the health and safety of staff and students. We upgraded our HVAC system, added portable HEPA filters to every classroom, installed UV lights in the classrooms, added hand sanitizer stations, introduced social distancing protocols, and established a weekly COVID-19 testing program. In addition, we offered a distance learning option and trained all staff and students on important safety measures. Thanks to these collective efforts, Hausner staff and students had a productive, positive year of learning.

Hausner students continued to excel taking top honors in the Synopsys STEM Fair, with a Hausner 6th grader winning second place in the Middle School Cognitive Science Division at the California State Science Fair. Hausner students also took top prizes in the American Mathematics Competition (AMC8) with one Hausner 8th grader scoring in the top 5% nationally. Hausner students also started their own student-led newspaper, held a film festival celebrating student developed films, and continued engaging in outstanding community service work through the Avodah L'olam program.

During the 2020-21 school year, our community came together with creative approaches to important Hausner traditions and rituals: teacher appreciation, Avodah L'olam, Purim, our spring fundraiser, and Yom Ha'atzmaut to name a few. We are especially grateful to have been able to host our 8th grade graduation outdoors with families and faculty safely gathering together to celebrate.

While we are hopeful that the challenges presented by the COVID-19 pandemic are mostly behind us, we are very proud of our community's resilience and our students' continued academic success despite these challenges. Most importantly, we are proud of the ways we all came together to support one another and make our community even stronger.

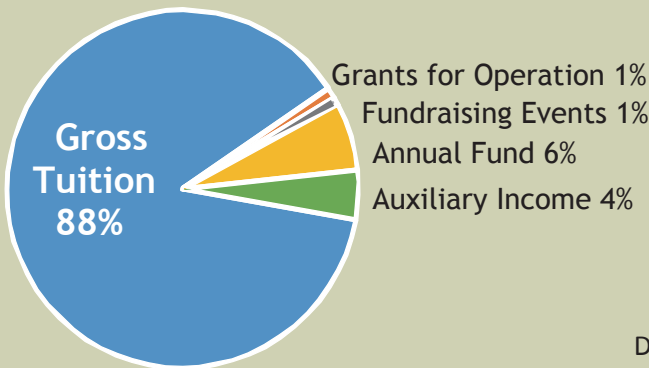

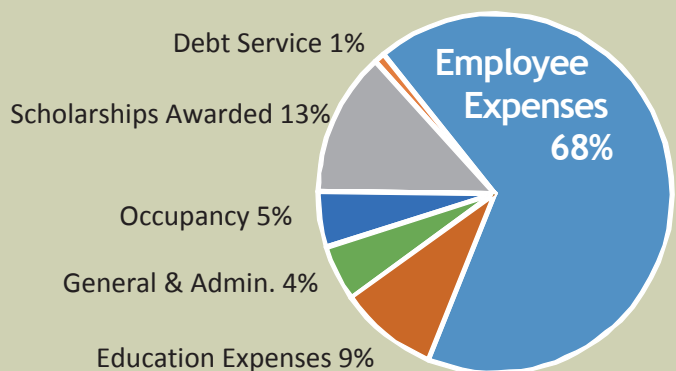

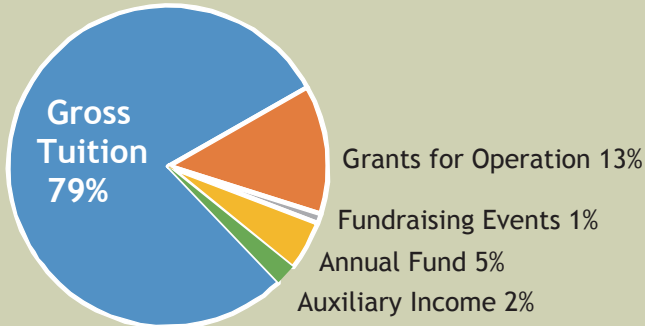
