**COVID-19 PANDEMIC WAIVER FORM FOR

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. **Over 600,000 people in the United States have died from COVID-19 as of the date of this form.** As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Salesian College Preparatory has put in place preventative measures to reduce the spread of COVID-19; however, Salesian College Preparatory cannot guarantee that an Off-Campus Coach, Volunteer, Contractor, Visitor (**“Invitee”**) or their family or friends or to anyone with whom such persons may have contact, will not become infected with COVID-19. Further, attending any activities associated with Salesian College Preparatory such as, but not limited to, attendance at school, being on campus, attendance for athletics, being with a club or other co-curricular activity, or any school function of any sort on or off its campus (“School Function”) could increase the risk to an Invitee or their family or friends of contracting COVID-19.

The Invitee named below confirms that the Invitee has not as of the date next to the signature below (“Effective Date”) tested positive for COVID-19, and as of the Effective Date is not presenting any of the following symptoms of COVID-19 listed here: Fever above 100 degrees Fahrenheit, chills, shortness of breath or difficulty breathing, new loss of taste or smell, dry cough, newly exhibited congestion or runny nose, sore throat, fatigue, muscle or body aches, headache, nausea or vomiting, or diarrhea (“Symptoms”).

Invitee agrees that on any date when the Invitee has any one of the Symptoms that Invitee shall not be allowed to be on campus or attend any School Function.

By signing this agreement, Invitee acknowledges the contagious nature of COVID-19 and voluntarily assumes the risk that Invitee or Invitee’s family or friends, or anyone who has contact with such persons may be exposed to or infected by COVID-19 because Invitee was on campus or attended a School Function and that such exposure or infection may result in personal injury, illness, permanent disability, and death to Invitee, or Invitee’s family or friends, or to anyone with whom such persons may have contact. Invitee understands that the risk of becoming exposed to or infected by COVID-19 may result from the actions, omissions, or negligence of Invitee, and others, including, but not limited to, Salesian College Preparatory employees, volunteers, students, other, program participants, and their families, friends, etc.

Invitee voluntarily agrees to assume all of the foregoing risks and accept sole responsibility for any injury to Invitee, or Invitee's family or friends, or anyone who has contact with such persons who suffer any harm (including, but not limited to, any personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind) associated in any way with Invitee's attendance on campus or at any School Function.

Invitee hereby releases, covenants not to sue, discharges, and holds harmless Salesian College Preparatory, its employees, agents, and representatives, of and from any claims, including all liabilities, actions, damages, costs, or expenses of any kind arising out of or relating to being on campus or the attendance at a School Function.
