The ideal candidate will have experience working with student performance data to successfully drive instruction in the classroom. Must have the ability to work in a cooperative manner with a variety of groups, including Business partners, parents and community representatives. Must have extensive experience with successful teaching techniques, instructional materials, and current trends. Must be able to train teachers in multiple content areas and have an understanding of strategies to challenge students to become high achievers. Must have the ability to instruct and advise teachers in the skills necessary to differentiate instruction for both low and high achieving students.
