Parent/Guardian Request for the Installation of Video and Audio Recording Equipment

In accordance with Texas Education Code § 29.022, a parent may request a video camera to be placed in their child's self-contained classroom or other special education setting in which a majority of the students in regular attendance are:

- (1) Provided special education and related services; and
- (2) Assigned to a self-contained classroom or other special education settings for at least 50 percent (50%) of the instructional day.

Once a request is made, the administration will make a determination on whether the child attends any class that meets the definition of a self-contained classroom or other special education setting under Texas Education Code § 29.022. The video cameras will be operated and maintained in the classroom or other special education setting as long as it continues to meet the criteria set forth in Texas Education Code § 29.022.

Staff Member/Trustee Request for the Installation of Video and Audio Recording Equipment

In accordance with Texas Education Code § 29.022, a staff member, parent, or trustee may request that a camera be placed in certain self-contained classrooms or other special education settings in which the majority of the student in regular attendance are:

- (1) Provided special education and related services; and
- (2) Assigned to a self-contained classroom or other special education settings for at least 50 percent (50%) of the instructional day.

A staff member is defined as a teacher, related service provider, paraprofessional, counselor, or educational aide assigned to work in the self-contained classroom or other special education setting; and a principal or an assistant principal of the campus at which the self-contained classroom or other special education setting is located. A Trustee is defined as a member of the District's Board of Trustees. 19 Tex. Admin. Code § 103.1301(b).

Once a request is made, the administration will make a determination on whether the classroom or other special education setting meets the criteria set forth in Texas Education Code § 29.022. The video cameras will be operated and maintained in the classroom or other special education setting as long as it continues to meet the criteria set forth in Texas Education Code § 29.022.

Request to Review Recording of Incident

In accordance with Texas Education Code § 29.022, the District will allow viewing of a recording if an incident report has been made AND a determination has been made by the Administration that an "incident" has occurred. An "incident" is an event or circumstance that: (1) involves alleged "abuse" or "neglect," as those terms are described in Family Code § 261.001, of a student by an employee of the school district or alleged "physical abuse" or "sexual abuse," as those terms are described in Family Code 261.410, of a student by another student; and (2) allegedly occurred in a self-contained classroom or other special education setting in which video surveillance under Education Code § 29.022.

If the recording depicts an incident, only that portion of the recording may be viewed.

When a determination has been made that an incident has occurred, the recording can only be viewed by the following:

- A District employee who is involved in an incident documented by the recording and who requests to view the recording;
- (2) A parent/guardian of a student who is involved in an incident documented by the recording and who requests to view the recording;
- (3) A peace officer;
- (4) A school nurse;

- (5) A District administrator trained in de-escalation and restraint techniques;
- (6) A human resources staff member as designated by the Board of Trustees and school policy;
- (7) Appropriate Department of Family and Protective Services personnel as part of an investigation of alleged or suspected abuse or neglect of a child in a public or private school under the jurisdiction of the Texas Education Agency; and
- (8) Appropriate Texas Education Agency or State Board for Educator Certification personnel or agents as part of an investigation.
