A RESOLUTION OF THE Lakeland Jt. School District No. 272 Board of Trustees AUTHORIZING THE ADOPTION OF THE KOOTENAI COUNTY MULTI-JURISDICTIONAL ALL-HAZARD MITIGATION PLAN **UPDATE**

WHEREAS, all of Kootenai County has exposure to natural hazards that increase the risk to life, property, environment and the County's economy; and

WHEREAS: pro-active mitigation of known hazards before a disaster event can reduce or eliminate longterm risk to life and property; and

WHEREAS, The Disaster Mitigation Act of 2000 (Public Law 106-390) established new requirements for pre - and post-disaster hazard mitigation programs; and

WHEREAS; a coalition of Kootenai County, Cities, Towns and Special Purpose Districts with like planning objectives has been formed to pool resources and create consistent mitigation strategies within the Kootenai County planning area; and

WHEREAS, the coalition has completed a planning process that engages the public, assesses the risk and vulnerability to the impacts of natural hazards, develops a mitigation strategy consistent with a set of uniform goals and objectives, and creates a plan for implementing, evaluating, and revising this strategy;

NOW, THEREFORE, BE IT RESOLVED that the Lakeland School District No. 272 Board of Trustees:

- 1.) Adopts in its entirety, Volume I and the introduction, chapter 28, Lakeland Jt. School District #272 jurisdictional annex, and the appendices of Volume II of the Kootenai County Multi-Jurisdictional All-Hazard Mitigation Plan Update (HMP).
- 2.) Will use the adopted and approved portions of the HMP to guide pre- and post-disaster mitigation of the hazards identified.
- 3.) Will coordinate the strategies identified in the HMP with other planning programs and mechanisms under its jurisdictional authority.
- 4.) Will continue its support of the Steering Committee and continue to participate in the Planning Partnership as described by the HMP.
- 5.) Will help to promote and support the mitigation successes of all HMP Planning Partners.

A RESOLUTION CALLING FOR SUPPLEMENTAL LEVY ELECTION

WHEREAS, in accordance with Section 33-802(3), Idaho Code, as amended, the Board of Trustees of Joint School District No. 272, Kootenai and Bonner Counties, State of Idaho (the "District") has determined there is a need for a supplemental levy in the amount of \$9,520,000 per year for two (2) years, for the purpose of paying all lawful expenses of maintaining and operating the District for the fiscal years beginning July 1, 2021, and ending June 30, 2023.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the District as follows:

- SECTION 1. That a supplemental levy election be and the same is hereby called to be held in the District on Tuesday, March 9, 2021, for the purpose of submitting to the qualified electors of the District the question set out in the form of the ballot appearing in Section 3 hereof.
- SECTION 2. That the Election Clerk of Kootenai County, Idaho (the "Kootenai County Clerk") shall administer and coordinate the election with the Election Clerk of Bonner County, Idaho (the "Bonner County Clerk") pursuant to and in accordance with Title 34, Idaho Code.
- SECTION 3. That the form of the official ballot will be substantially as follows:

QUESTION: Shall the Board of Trustees of Joint School District No. 272, Kootenai and Bonner Counties, State of Idaho, be authorized and empowered to levy a Supplemental Levy in the amount of nine million five hundred twenty thousand and no/dollars (\$9,520,000.00) per year for two (2) years, commencing with the fiscal year beginning July 1, 2021 and ending June 30, 2023, for the purpose of financing any lawful expenses of

maintaining and operating the District; all as provided in the Resolution adopted by the Board of Trustees on December 8, 2020?

SECTION 4. That the form of notice of the election shall be substantially as follows:

NOTICE OF SUPPLEMENTAL LEVY ELECTION

Notice is hereby given that pursuant to the laws of the State of Idaho and the Resolution of the Board of Trustees of Joint School District No. 272, Kootenai and Bonner Counties, State of Idaho, adopted on December 8, 2020, a Supplemental Levy Election will be held on March 9, 2021, between the hours of 8:00 a.m. and 8:00 p.m. for the purpose of voting upon the following question and proposition of authorizing a levy:

Shall the Board of Trustees of Joint School District No. 272, Kootenai and Bonner Counties, State of Idaho, be authorized and empowered to levy a Supplemental Levy in the amount of nine million five hundred twenty thousand and no/ dollars (\$9,520,000.00) per year for two (2) years, commencing with the fiscal year beginning July 1, 2021 and ending June 30, 2023, for the purpose of financing any lawful expenses of maintaining and operating the District; all as provided in the Resolution adopted by the Board of Trustees on December 8, 2020?

- SECTION 5. That the Clerk of the Board of Trustees of the District is authorized to convey to the Kootenai County Clerk and Bonner County Clerk (the "County Clerks") the forms of the Official Ballot and the Notice of Supplemental Levy Election, appearing in Sections 3 and 4 hereof, for election preparation and publication pursuant to Title 34, Idaho Code. The Clerk shall submit these forms to the County Clerks prior to January 21, 2021.
- SECTION 6. That the County Commissioners of each of Kootenai County and Bonner County, Idaho, shall act as the canvassing boards pursuant to and in accordance with Title 34, Idaho Code, and will convey the results to the Board of Trustees of the District as provided therein.
- SECTION 7. That if at the election a simple majority of the qualified registered electors of the District authorize such levy, the supplemental levy shall be approved and become effective in accordance with the provisions of Section 33-802, Idaho Code.
