After lunch, many alumni made a day of it by staying on campus to watch the Gilbert-Northwestern Yellow Jackets play Canton High School.



We encourage the nomination of individuals who exemplify and embrace such excellence, reflecting the proud legacy and tradition of their alma mater. Based on that legacy and tradition, we are honored to recognize individuals in the following five categories:



#### THE GILBERT HERITAGE AWARD

This award may be presented annually to an alumnus of The Gilbert School who, through significant personal or professional contributions or accomplishments during his/her lifetime, has distinguished him/herself within the history of the school, bringing honor and pride to all alumni and representing the traditions and the heritage of The Gilbert School. The Gilbert Heritage Award may be given posthumously.

#### YOUNG ALUMNI ACHIEVEMENT AWARD

This award may be presented annually to an alumnus of The Gilbert School who graduated from Gilbert within the past twenty years. The recipient will have achieved outstanding personal or professional success in the community, in business or in entrepreneurship. Through such accomplishments, he or she serves as a role model for younger individuals.

#### DISTINGUISHED PROFESSIONAL ACHIEVEMENT AWARD

This award may be presented annually to an alumnus of The Gilbert School who has demonstrated outstanding achievement in his or her professional life. The length and quality of career accomplishments, a commitment to professional excellence and respect among professional colleagues is noteworthy.

#### THE W.L. GILBERT AWARD FOR OUTSTANDING COMMUNITY SERVICE

#### **OUTSTANDING ACHIEVEMENT IN ATHLETICS AWARD**

This award may be presented annually to an alumnus of The Gilbert School who, through participation on a sports team while a student at Gilbert, exhibited outstanding character, sportsmanship and his or her own "personal best" skill level while contributing to the overall achievements of the team. The recipient's positive attitude and team approach was evident and respected not only within the competitive venue but also in the classroom and greater community. The recipient may also have distinguished himself or herself in the field of athletics after graduating from Gilbert. The recipient must be an alumnus of a class that graduated at least ten years prior to the year of the award.

The completed nomination form, along with all supporting documentation, must be submitted to the Office of Development and Alumni Relations no later than June 1, 2013. In order to be eligible for nomination, the nominee must be a graduate or former student of The Gilbert School unless otherwise stated in the description of the award. Current members of The W.L. Gilbert School Corporation and The W.L. Gilbert Trust Corporation are not eligible while in service to these boards.

The Gilbert School Alumni Advisory Council, representing all alumni of The Gilbert School, will review the nominations and present their recommendations to the Executive Committee of The W.L. Gilbert Trust Corporation for final confirmation. The Alumni Advisory Council reserves the right to include for consideration an ongoing list of potential nominees provided by The Gilbert School Alumni Office. Nominations will be accepted from alumni and friends of The Gilbert School at large.

# Gilbert Trust Hires New Team For International Residency Program

#### Letter From The Admissions Director


Greetings Alumni/ae!

My name is Tim Cronin and I am the Dean of Admissions for the W.L. Gilbert Trust. I have been hired to work with Head of School Dr. Anthony Serio to establish the International Residency Program. This is a very exciting program for the W.L. Gilbert Trust and these students are very excited to become a part of The Gilbert community.

I graduated from Post University with a master's in business administration and from Central Connecticut State University with a bachelor's degree in business management and organization. I began my career in admissions at Post University in Waterbury, Conn., working with the online degree programs. During this

time I successfully trained some of the top admissions representatives in the departments. More recently, I worked at Lincoln College of New England (formerly Briarwood College) in Southington, Conn., as a high school admissions representative. We have seen great success with international students so far. We currently have 57 student applications. Of these 17 have made financial commitments to attend The Gilbert School for the Fall 2013 school year and two other students who have verbally committed. We expect to see about 20 international students in the fall.

#### Willis Whalen '84 Pursues His Dream

The career of Willis Whalen '84 is a classic mix of aspirations, hard work and practicality.

Whalen had a passion for football early on, playing the game at Gilbert for the late Charles Youmans. Whalen also played baseball and wrestling -- the latter because "Mr. Youmans talked me into it."

"The thing I enjoyed most about football was just bonding with the guys," Whalen said in a recent interview."

His best friends were Coach Youmans' son, Jay, and Leon Veretto. The trio continually tried to outdo each other in workouts.

"Finally, my junior year I realized I wanted to go to college and keep playing," Whalen recalled.

He played one year at Southern Connecticut State University, then played semi-pro ball for the New England Crusaders in Hartford. Whalen also worked on the side as a personal trainer but "always knew I wanted to get into the NFL in any capacity, maybe as a strength and conditioning coach, whatever."

"I played five years with the Crusaders, then in '89 I got invited to a huge semi-pro all-star game with 100 of the best semi-pro players in the country," Whalen continued. "They were going to pick 50 of them to create Team USA, which was going to be the U.S. representative team to go out and play teams from different countries. I was elected captain."

Later, Whalen landed a summer job running youth programs for his favorite NFL team, the Miami Dolphins.

"I had to leave my job for three

months to do that summer program with the Dolphins," Whalen said. "There was no guarantee that the Dolphins would hire me permanently, but obviously it worked out."

Whalen wound up staying with the Dolphins for eight years before landing a gig with the NFL Players Association, the labor union that represents thousands of league players. Whalen is manager of player services and development.

"Mr. Youmans was always telling me to be prepared and have a back up plan if I couldn't play in the NFL, then good things were going to happen. I tell kids I never made it in the NFL but I'm as close to that as you can possibly be."

In 1997, Whalen was inducted into the Semi-pro Football Hall of Fame. He was touched that Youmans made the trip to Canton, Ohio, and gave Whalen's induction speech.

Whalen grew up on Beech Street, was a four-year Gilbert student and had one older brother. Both has very positive experiences at TGS.

"Any of the experiences I had there helped me become what I am today. I am grateful."

Whalen gives back to his alma mater by leading a fundraising effort every summer to benefit a Gilbert Trust scholarship in memory of his friend, the late Ean Clough '84, with whom Whalen was cocaptain of the football team their senior year.

Whalen lives in Loudon County, Virginia, with his wife Melissa and their children, Skylar, 10, Austin, 7, and Bryce, 6.

In what little spare time he has, Whalen is studying for a matser's degree in sports adminsitration at Southern New Hampshire University. In other words, life is good.

### Hi Tech: TGS Becoming An iPad Campus



Apple iPads have finally arrived on the TGS campus.

The entire faculty received the tablet computers before Christmas as part of the first phase of a program which should result in the iPads finding their way into the hands of all of Gilbert's students.

In February, upperclassmen rececived iPads. Freshmen and sophomores should receive them next year.

Eventually, the devices are expected to replace most textbooks, relieving young scholars of the burden of carrying around heavy backpacks. The technology will also facilitate communication between students, teachers and parents.

Thanks to a federal grant, the school bought 230 iPads. The devices will also be made available to 7th- and 8th-graders, though they will not be able to take them home.

### About The Trust Homestay And Ambassador Programs

The W.L. Gilbert Trust Corporation is the umbrella organization for Homestay, Vacation Family, and Student Ambassador Programs. Its mission is to foster understanding and promote cultural exchange among Trust international students, Gilbert students, and area families. These programs pave the way for local residents and teens to make profound connections with the Trust international students.

The W.L. Gilbert Trust Corporation HOMESTAY Program offers our new students language and cultural immersion in a nurturing and comfortable home environment. In turn, families can look forward to sharing their homes with young people who are ready for new adventures and excited to talk about their own family traditions and home life.

Homestay applications are completed by prospective parents and students, and matches are carefully considered based on information provided during the application process. Typically one or two students are placed with a Homestay family, and though all placements are for one school year, there is an option to continue in Homestay during subsequent years. Participants in the Homestay Program become part of the larger Homestay community where families support families and everyone enjoys a special year filled with Homestay family events.

Families who are interested in hosting for shorter periods can take part in The Gilbert School volunteer VACATION FAMILY Program and open their homes to summer and winter camp sister-school students during school vacation weeks.

#### AMBASSADOR PROGRAM

It's all about teens connecting with teens. Ambassadors attend meetings, enjoy dinners with international students, and plan special monthly events bringing Gilbert and residential students together for companionship and fun. Through these shared experiences, everyone soon discovers they have more in common with their international peers than they ever would have imagined. dents.


