With many schools having Early Decision, Early Action, and Priority deadlines of November 1, students and counselors have been processing applications, essays, supplemental writing pieces, portfolios, and Bullis School-specific materials.

To date, our students have submitted 577 applications. Many of our students who have applied through Rolling Admission plans have already received some decisions! 17 acceptances have been offered. Our next big deadlines are November 15 and December 1.

As a reminder to our seniors, please let us know of *all* admissions decisions.



## Financial Aid Follow-Up

Last month, we shared helpful information for families applying for need-based financial aid. As we noted, the "universal" financial aid application form is the Free Application for Federal Student Aid (the FAFSA). Before completing the FAFSA, students and *one* parent need to create unique FSA IDs. The ID grants access to federally-funded loans and serves as a signature for the FAFSA itself.
