





Planned actions did not differ substantively from the actual implementation. Our professional development plan was especially successful, as the school was able to regularly support instructional staff with a variety of content area trainings in response to needs assessment data. An area of challenge was to create a Master Schedule that provided for consistent Response to Intervention and Instruction, Dual Language Immersion, and Designated English Language Development.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were additional expenses for Special Education due to a larger than expected group of Students with Disabilities.

CAASPP scores in ELA increased since last year. Math scores were down, but YTD growth met the target on NWEA MAP, which speaks to effective teacher training (Action 1.1) and academic interventions (Action 1.2). English Learner Programming and Supports (Action 1.3) was universally implemented. This resulted in Very High English Learner progress. The school offered consistent support and programming for our Special Education students (Action 1.4).

The school faced challenges finding meeting times that worked for all of our parent body, but continued to leverage technology in order to promote access and involvement.

Staff report the training they received was sufficient in most areas (Action 2.1). There is still a need to implement strategies to promote social-emotional health and to increase school connectedness. Surveys demonstrate that the majority of parents have positive perceptions of engagement initiatives (Action 2.2). However, the school will continue to promote increased parent involvement and attendance at school events. The school maintained existing partnerships and pursued new relationships as part of a community school initiative (Action 2.3).

YTD suspension rates are down significantly, and staff will use evidence-based practices (Action 2.4) practices to proactively address behavioral issues. YTD Chronic absenteeism is also on track to decrease significantly (Action 2.5).

The school will add a staff survey metric related to shared decision making. Behavioral Interventions and Support (Action 2.4) will be moved to the "A safe and functional learning environment" Goal, along with suspension/expulsion metrics. The school fulfilled its base staffing needs (Action 3.1) despite a shortage of qualified applicants. Observations and evaluations (Action 3.2) show that staff members are effective in the classroom and other duties. The school invested in operations (Action 3.3) and earned a "Good" rating on the inspection tool. Surveys indicate a wide variety of educational partners perceive the school as safe (Action 3.4). The curriculum inventory shows the school purchased sufficient instructional materials (Action 3.5) and provided additional supplies for low-income students. The school maintained a 1:1 student-to-device ratio and all students had access to the internet in order to complete coursework (Action 3.6).

King-Chavez Arts and Athletics Academy (KCAA) is a public charter school serving grades 4 and 5. KCAA forms part of the King-Chavez Neighborhood of Schools (KCNS), a network of charter schools in the Historic Barrio District of San Diego. The school has an enrollment of about 162 students. Approximately 96% are Hispanic and 49% are designated as English Learners. 93% of students are socio-economically disadvantaged, and 18% are Students with Disabilities.

Our mission is to "Seek excellence in Academics, the Arts and Athletics from the Foundation of Love." We strive to prepare students to flourish in school and in life as they meet the challenges of the 21st century. In keeping with our philosophy of educating the mind, body, and spirit, students actively learn academic content while expressing their creativity. Teachers work with a standards-based curriculum emphasizing literacy and analytical skills development.

#### **Reflections: Annual Performance**

CAASPP English Language Arts: English Learners scored significantly lower than All Students. The school will close this gap through Focus Goal 2 "Close the English Learner achievement gap."

Teachers: Instructional staff indicated a need for content-area specific training (Goal 1, Action 2). They are also interested in exploring standards-based instructional materials in mathematics (Goal 4, Action 3).

Principals and administrators: Review of English Learner academic achievement showed a performance gap. This group signaled a need for systemic support for English Learners (Goal 2).
