**SUPERINTENDENT'S REPORT**

Mr. Broadnax announced that the Teacher Cadet program, which was a part of summer school, will be offered as one of the new and innovative CTE that the district is offering. The first Administrative Council meeting, which consists of the Executive Cabinet as well as principals and vice principal from each school was held August 16, 2021. This is important because the principals should be involved in the decision-making process for CCS students. Preparations for expanding the District's Virtual Academy is underway with hope of challenging curriculum by the 2022-23 school year. The Superintendent's Back-to-School Kick-Off was a huge success and more than 320 backpacks with supplies were given to the attendees. Enrollment strategies are ongoing and include a commercial on WXYZ. There was also a follow-up story with WDIV pertaining to the protocols that the district enacted for the remainder of summer school.


