2. The full scholarship will be applied to the tuition fees of the eligible program including books and materials fees.
3. This scholarship is applicable only for on-campus studies and scholarship recipient must have an approved and valid study permit.
4. Two scholarships will be awarded. The scholarships are available for applications sent by January 31, 2022.
5. This scholarship is only applicable for international students.
