A.) Meeting Opening/ Attendance

The meeting was called to order by Dawn Zimmerman at 6:36PM.

B.) Welcome and Opening Remarks from Chairperson

D.) Public Comment

No comments from the public

E.) Approval of Meeting Minutes from 5/19/21 Meeting

<u>Dr. Mercanti-Anthony moved to approve the 5/19/21 meeting minutes. The motion was</u> seconded by Caroline Lerum.

All in favor, none opposed.

F.) Remarks and Updates from the Interim Chief Officer of Special Education and Student Supports, Dr. Heiligenthaler

A lot of our work is being centered around PCG recommendations. There has been reorganization out of central office. More support for students and staff at schools. Special Education Coordinators are in schools supporting administrators and children on site. Central office is here to help. Part of change of name and logo. (SH)

Updated our transportation procedure to make it smoother. Bumps in transportation as coordinator no longer at GPS. Work going to getting students on busses. PPTs determine whether transportation is needed as a related service. GPS streamlining process so students are on bus within five days. In the process of looking for new transportation coordinator. (SH)

Focusing on co-teaching and supporting school teams with co-teaching. There are 8 sections of co-teaching at HS (4 english and 4 math). CMS has 5 teams of co teaching. Both sites being supported by Dr. Luddy of Luddy & Associates. Providing coaching and real time supports. Dr. Luddy is working case-by-case with students across the districts. (SH)

Several of the elementary schools have participated in co-teaching training over the summer, specifically with Dr. Paula Kluth who's been working on summer seminars. Glenville specifically participating. (SH)

Can you explain diff between collab and co-teaching? (AD)

It's the same thing but another terminology (SH)

Are those classes mixed? (AD)

They are mixed. (SH)

No class is over 50% with students with disabilities. There are a few classes that might be sped classes - 100% sped b/c that class is a sped class. The goal is to get to 30-33%. Hard to make some changes by the beginning of the school year. Thanking administrators and teachers for balancing classes. (SH)

There are some classes at the high school that can't be under 50% because the percentage of students with disabilities is at about 70% in some classes. Higher number of students with disabilities enrolled in those classes to decrease class size. (SH)

Looking toward how GPS can look at what students can move up to the next level in class and the utilization of Assistive technology. (SH)

Hired 0.5 Assistive Technology (AT) Director Megan White. Need to backfill teacher of the hearing impaired. (SH)

Have a plan to support elementary, middle and high school teams; professional development; 1:1 support and small group support. (SH)

Collab and coteaching: some teachers have the training, and some don't have the training. Last year there was a sp. ed. teacher and general ed. teacher but they weren't working together. (SH)

Dr Luddy is coaching at CMS and GHS by going into the classrooms and working directly with teachers in real time. There are some individual supports she's providing but not everyone has been immersed in it. The district is starting down the path. Biggest difference is that many staff have had more of a lecture-type training in coteaching but Dr. Luddy is looking at how that works in the classroom (the actual teaching practices) and giving feedback.

Is Dr. Luddy going to provide this support to the other schools in the district? (AD)

She's been working with the district for several years and with Glenville (SH)

EMS hasn't had training and just has 2 teachers in the classroom. What's happening at EMS and WMS? (AD)

EMS is running a different model and doesn't have coteaching so I can't answer that right now. (SH)

Happy we're having an open discussion about all of this. (AD)

We're looking at PD and how are we helping our teachers in the classroom. A lot of staff are participating in trainings and looking to see how that translates. UDL working with our curriculum team and how they are putting that in the curriculum in gen. education.

Looking at MTSS and how are we helping our teams in interventions. This is a change in mindset. We are here as a resource and support in the classrooms. All coordinators' assignments have shifted so they are in the classrooms. (SH)

G.) Remarks and Updates from Superintendent

Grateful to have Dr. Heiligenthaler leading GPS with PCG recommendations. She's helping the staff understand procedures to update district and stay current. Shes' very positive, bold and student and child first. Working on community input on procedure manual and PD. Connection between sped, gened and entire curriculum team. We were a culture of no and that's not how we want to be seen by our families. We have an opportunity to create world class sped program. Phenomenal start to the year. (TJ)
