

Public Notice of Filing for the Center School District #58

The Center School District #58 in Kansas City, Missouri, encourages qualified persons interested in running for a position on the School Board to file to be a candidate in the April 5, 2022, election. **Two (2) positions, both with three (3) year terms, are up for election on that date.**

Interested persons must meet each of the following qualifications to file:

1. Must be a citizen of the United States.
2. Must be a resident taxpayer of the Center School District #58.
3. Must have resided in Missouri for a minimum of one (1) year immediately preceding the election date.
4. Must be at least twenty-four (24) years of age.
5. Must not be delinquent in the payment of any state income taxes, personal property taxes, municipal taxes, or real property taxes on their place of residence. If an applicant is a past or present corporate officer of any fee office, that office cannot be delinquent in the payment of any taxes owed to the state.
6. Must also be eligible to hold office in accordance with Missouri law, including §115.306, RSMo.
7. Must have not been found guilty of nor pled guilty to a felony under the federal laws of the United States of America.
8. Must not be registered or required to be registered as a sex offender under Missouri law §162.014.
9. Must have filed all required campaign disclosure reports with the Missouri Ethics Commission, if applicable, for all previous elections in which they were a candidate, §130.071, RSMo.

Filing Information

Qualified applicants for the Board may file in person in the district office located at 8701 Holmes Road. Ballot order will be determined by the order of candidate filing. **Interested candidates will form a line at the front door of the district office, 8701 Holmes Road.** If you have any questions about this process, please review Board Policy BBB-3, located on the district’s website. In the event the Center School District is closed due to COVID-19 during the filing period, candidate filing at the Board of Education Office will be by appointment only. In the event of such closure, interested persons should contact the Secretary of the Board of Education at the information listed above to schedule a filing appointment.

Appointments shall only be scheduled on the above-listed regular business days and limited office hours. The ability to file by appointment shall only extend to closure due to COVID-19 and shall not allow a candidate to file on days the Board of Education Office are closed for inclement weather or other non-COVID-19 related reasons. Interested persons filing in this manner will continue to be placed on the ballot in the order of filing.
