Concerns regarding work session agenda

Hello Trish,

I had wanted to call you this evening but it got to be too late. My schedule is quite packed Thursday and Friday, so I'm afraid I may not have an opportunity to talk. If you have time over the weekend, I would truly like get together and talk before our agenda setting meeting on Monday, if at all possible. Below are some concerns I'd like to discuss.

I am confused as to why the agenda setting for our upcoming work session as been done in a process different than our monthly board meetings. I certainly have no objection to soliciting suggestions for topics from board members since work sessions are less frequent, longer in length, and purposely designed to get deeper into certain topics. However, the process beyond that should be the same for many reasons:

- **A regularly designated time for agenda setting allows any board member to attend and to offer input;
- **Many items have already been slated for this work session and need to be incorporated;
- **There are additional items that need to be included due to timing issues;
- **It is important that the superintendent is involved in agenda setting and not just instructed as to what will be discussed. He is responsible for ensuring the Board has timely information, meets regulatory requirements, etc. If he does not have input on the agenda, he can not be held accountable if anything is missed, and finally;
- **There is a policy outlying how items are placed on an agenda: 1) a minimum of three board members request an item be placed on an agenda (timing determined by officers); 2) the officers determine an item needs to be on an agenda; or 3) the superintendent requests an item be placed on the agenda and officers concur. Likewise, committee agenda items come from either the Board or from superintendent/staff when action is required. The chair, whether for the Board or a committee, does not have authority to unilaterally add agenda items.

Additionally, I have concerns regarding several of the topics placed (or not placed) on the proposed agenda. Some of these concerns are:

- **Cross-walk of policies and regulations: I'm not sure why this needs to be discussed at the work session. This should be done by staff and is actually already in progress;
- **Legal Counsel for Board: The Board already has Counsel, so should I assume the discussion would be to change that which is currently in place? Or, is this a placeholder for something else? If my assumption is correct, presumably we are dissatisfied with current representation which would inherently mean this is a personnel issue and not to be discussed in a public setting without first discussing it with the employee. Since we only have one Counsel, the employee in question is easily identifiable and I believe placing this on an agenda puts the District in a position of liability.
- **The budget cannot wait for committee level discussion. It is essential that an initial presentation be made to the full Board at this work session.
- **Similarly, if start times are to be changed, that discussion must happen ASAP and, in my opinion with the full Board, so that the public is fully aware of the discussion. Any changes should be incorporated into the calendar discussion/announcement. Waiting for a committee to discuss, make a recommendation to the Board, and receive public input could preclude that from happening.

Finally, I'm curious as to your use of all caps for 'Board' in your final paragraph. I read that to mean discussions at this work session (either all or some) are to be that of the Board only and not involve the staff. I hope I am incorrect in my interpretation. I believe, fundamentally, all discussions of school boards should include their

superintendent unless it is regarding continued employment, and then only after any concerns are addressed prior to such discussion. I feel this is true in email as well. BOE ONLY should be used for circumstances when the superintendent needs to correspond confidentially and for board members' subsequent responses. If the superintendent (and his staff) is not included in discussions, how can we expect him (them) to be adequately prepared to meet our needs?

After re-reading my email, I realize it may sound that I am challenging your position and that is not what I mean to do. I sincerely just wish to ensure we, as officers, are leading the Board in the most effective manner and I'm afraid we may be veering off that path. I am not a fan of discussions via email; as I said earlier, I would really like to meet with you if possible. Please let me know if there is a convenient time this weekend.

Dr. Patricia Felton-Montgomery called the meeting to order at 5:00p.m.

Mr. Bill Payne made a motion to go into Executive Session for the purpose to discuss the employment, appointment, compensation, promotion, demotion or discipline of employees; receipt of legal advice relating to a pending, threatened or potential claim or other matters covered by the attorney-client privilege; and litigation update. The motion was seconded by Mrs. Mary Cordray. The motion passed 9/0. Mrs. Evva Anderson was absent from the vote.

Dr. Montgomery called the Open Session to order at 6:10.

There was no Action Coming from Executive Session

Mr. Joseph Dunkle requested that the January 3, 2017 board meeting minutes be pulled from the consent agenda and moved to Board Action.

Mrs. Geri Kinton made the motion to approve the agenda. The motion was seconded by Mr. Bill Payne. The motion passed 10/0.

The Pledge of Allegiance was recited and Dr. Montgomery stated that the media was properly notified.

The musical performances were given by the M.C. Riley Elementary Singing Eagles chorus and the Bluffton Elementary School chorus. Both groups sang their official school pride songs.

Mr. Earl Campbell requested a moment of silence in memory of Paul Krohne, the former director of the South Carolina School Boards Association who passed away last week.

Under Points of Celebration, Dr. Moss recognized the following people:

- Brady Scott, the Character Education Student of the Month for southern Beaufort County, a 6th grade student from H.E. McCracken Middle School.
- Mr. B.J. Payne, Hilton Head Island High School's football coach. He was nominated by the
 Carolina Panthers for the NFL Don Shula Coach of the Year Award. Each NFL team got to
 nominate a high school coach who exemplifies leadership, integrity and achievement. The
 winner will be announced during the NFL Honors gala in Houston on Feb. 4, the night before the
 Super Bowl. The award comes with \$25,000 from the NFL Foundation \$15,000 for the coach
 and \$10,000 for the school's football program.

Public Comment

Anthony Cambria, Hilton Head Island community member, addressed a variety of issues that he believed the Board could have handled better in 2016 and offered challenges for 2017.

Richard Bisi, president of CARE, addressed achievement gaps involving Hispanic and African-American students.

John Giesler, Hilton Head Island community member, encouraged the school district to put a plan together to improve its communications with community stakeholders and get word of all the good things happening out.

Chris Donelson advocated changing school start times so that elementary-grade students can begin classes later in the mornings.

Skip Hoagland stated Board members should not have policies that abridge First Amendment rights of free speech.

Comment Corrections

Mr. Joseph Dunkle addressed population statistics for students enrolled in the district that were offered in public comment.

Chair's Report

Dr. Montgomery thanked Board members for the support she has received from them since her election two weeks ago, and she also commended Monday's celebrations across the county that honored the Rev. Martin Luther King. Dr. Montgomery announced the chairs and members of the Board's various committees. Committee chairs announced were David Striebinger (Legislative), JoAnn Orischak (Curriculum and Instruction), Bill Payne (Finance and Operations), Joseph Dunkle (Human Resources), and Evva Anderson (Student Services). Members to serve on the ACE Board are Earl Campbell, Mary Cordray and Geri Kinton.

Superintendent's Report

Principals Jerry Henderson (H.E. McCracken Middle School) and Neodria Brown (Hilton Head Island Middle School) updated Board members on first-semester student achievement data as well as notable initiatives at their schools.

Dr. Dereck Rhoads presented preliminary data from fall administrations of the state end-of-course exams. Dr. Rhoads answered questions, particularly about reducing achievement gaps.

Dr. Moss updated Board members on the school choice program for the 2017-18 academic year. Choice applications go online February 1, and the deadline to apply is February 28. District-wide choice fairs will be held north of the Broad and south of the Broad as well as at individual schools.

Dr. Moss briefed Board members on the results of employee surveys to determine which of two calendar options they preferred for the 2017-18 academic year and which of two options they preferred for the 2018-19 academic year. Dr. Moss asked and Board members encouraged parents and community members to contact state legislators and urge them to restore locally elected school boards' abilities to determine academic calendars rather than having the General Assembly mandate calendar start times for all districts statewide. A bill has been prefiled in the House of Representatives that would accomplish that goal.

Mrs. Evva Anderson made the motion to send another calendar survey to teachers with Option A and to also include the suggested calendar received from several teachers as Option B. Option B extends the Christmas break. The motion was seconded by Mrs. JoAnn Orischak. The motion passed 8/1/1. Earl Campbell voted against, and Joseph Dunkle abstained.

Dr. Moss reviewed the actions of the South Carolina Education Oversight Committee, which has been working to establish a single accountability system for state school districts rather than having districts operate under one state accountability system and a separate federal system.

Dr. Moss responded to Board members' requests for South Carolina school districts that compare to Beaufort County in terms of poverty index and student enrollment. He identified Aiken, Pickens and Rock Hill District 3.

Dr. Moss addressed the recent events at H.E. McCracken Middle School regarding checks for students possibly violating dress code. He stated said school staff across the district should not physically touch students' clothing. He said he would reiterate proper procedures with all of the district's principals. Dr. Montgomery directed that the dress code issue, including enforcement practices, be taken up by the Board's Student Services Committee.

Dr. Moss reviewed May River High School's response to a video that showed a student throwing a soccer ball at a school resource officer riding a bicycle.

Dr. Moss addressed the district's facilities use procedures as they apply to high school tennis court complexes. Mr. Payne asked when hurricane-related damage to Hilton Head Island High's tennis court complex would be repaired, and Dr. Moss replied federal hurricane relief procedures had delayed the repairs. Bids will soon be accepted on the repairs.

Dr. Moss said he had requested feedback from the District Teacher Forum on a proposal that would allow teachers to receive financial compensation for unused sick days. He will bring the feedback back to the Board.

Dr. Moss informed the Board regarding a 2006 refinanced bond which exceeded savings limitations thus requiring refund to IRS.

Dr. Moss announced Hilton Head Island High School had received IB renewal.

Dr. Moss announced funding of nearly \$900,000 through a sate proviso and CERRA to be used as incentive pay for critical and hard to fill positions as well as special education.

Board Business Action

Mrs. Mary Cordray made the motion to approve the Resolution supporting School Choice Week. The motion was seconded by Mr. Bill Payne. The motion passed 7/3. Earl Campbell, Patricia Felton-Montgomery and David Striebinger voted against.

Ms. Orischak requested a briefing from staff regarding how special education students' medical needs are being met during the instructional day. Ms. Anderson requested a briefing on the academic performance of students from minority groups. Both topics will be added to the Board's next work session.

Mr. Joseph Dunkle made a motion to accept the January 3, 2017 Board Meeting Minutes with corrections noted. The motion was seconded by Mrs. Mary Cordray. The motion passed 10/0.

I'm a single mother to 2nd and 3rd graders at school start times to previous years going around with heavy media coverage (both social and traditional media). I understand the petition owner, Mr. Donelson, was advised to collect 500 signatures and present to the next board meeting.

I'm also the one who have been conducting an unofficial survey off Facebook to see why the new start times were affecting kids in so many different ways (I'm an engineer by training so I'm intrigued by things like this, and feel the urge to find out why). Because of the tool I had available to conduct the survey, it wasn't scientifically or statistically sound to say the least. But I CAN tell you for certain, based on what I saw in the survey responses and what I hear from other parents and staff, is this: the petition is **extremely one-sided**.

Pardon me for pulling the numbers again (I'm an engineer after all....I apologize): According to the BCSD website, we have approximately 10,000 elementary school kids enrolled in BCSD schools. Let's just say the petition succeeds in getting the 500 signatures Mr. Donelson was advised to obtain; that's only <u>5%</u> of the entire student body! And if you comb through the signatures, many don't even live here or have any children attending BCSD schools. In my opinion, these signatures should be thrown out. So let's say it only has 300 valid signatures - so, 3%? Are the Board going to listen to (and god forbid cater to) the 3% who screams the loudest and disregard the opinions of remaining 93% of the student body?

To be perfectly honest, I am neither for nor against the earlier start time; I was raised in a culture that whatever changes made, we just suck it up: Improvise, Adapt and Overcome. Fortunately my own sons are not having any difficulties this year in quite a drastic contrast to what is portrayed in the petition drive; but if they were, my first instinct as a parent would be to find a way to adjust whatever is needed in our routine - whether it be a earlier bed time, less extracurricular activities, alternate after-school care arrangements, whatever that seem to be causing the difficulty - to make it work, for us. I'm sure I would be heart-broken to see my littles so exhausted every day, but that would NOT prompt me to drive a change that affects 9,999 other students so that MY children would be happier!

I know the start time change was well-considered, thoroughly-discussed and vetted before it was implemented district-wide, and that the change was mainly driven by the improved academic performance at high school grades. And to address the bussing issue with the later start-time for MS/HS, ES had to get to bumped up by 45 **minutes.** And I know it was well-publicized for almost a year going into the SY 2016-2017. Yet some parents claim they were completely blind-sided; and I know for a fact those are the ones who are quite vocal in this petition.

I truly do realize this is NOT an easy thing to "undo" as many seem to think; it is a multi-faceted logistical challenge. I was a program manager in aviation industry for 15 years so I know the challenges that goes with issues such as this, so I don't envy you for having to hear the loud voices while trying to decide what's in the best interest for the students.

As a parent, I beg of you the Board Chairwoman to please keep an open mind when this petition is presented before the board and remember the number it represents: 5% of the entire elementary student body at most. My unofficial survey indicated (although with a very very small sample size of 60) that the sentiment isn't as overwhelming as the petition presents itself to be. I also urge you to motion the board to conduct an "official" survey sent out to the parents of BCSD schools; in fact, I already have a survey modeled in SurveyMonkey I would be happy to share with the board to use. It should be presented as a tool to identify what's working/not working and identify rooms for improvement rather than a "vote" as many parents want. I know a "vote" would only generate heated arguments and resentments toward the board no matter what the outcome might be - we just can't please everyone, that's a given, But if we have a solid, scientific data in our hands, showing what's working/not working and why, we can all put aside the heated emotions such as this petition and start identifying a best solution that works for most.

Again, I apologize for my rambling, but I feel very strongly about this petition and its motive being one-sided. If you'd like to discuss this further, I would be more than happy to do so. And thank you for all that you do for our children.

Since our agendas are set for the next two Curriculum and Instruction committee meetings per your email this weekend, can we add a "follow-up review" of school start times to our **April** agenda? I am not certain what other items you have planned for April's meeting, but since May marks the end of our first year district-wide with new school start times, it would be an appropriate time to review.

Also, I'd requested at our work session to be presented with other options that would get all our students district-wide to their schools at the same time. i.e. 1) An analysis of younger and older students riding same buses, and 2) price tag for adding additional buses to our fleet that would allow younger students on dedicated buses to go out to schools at same time as older students.

We're still receiving feedback on this matter. Whether it is in the form of the 500 signature petition Mr. Donelson is working on or emails from Keiko Holton below. I think there is value in presenting what other options and logistical challenges would be required to get all our students to school at the later start time. It's also of value to present the public with DOCUMENTED areas of improvement as of this change.

Day 1, November 18, 2016

Mrs. Mary Cordray called the meeting to order at 8:44 a.m.

Mr. Bill Payne made the motion to approve the agenda. The motion was seconded by Mrs. Evva Anderson. The motion passed 6/0. Earl Campbell, Joseph Dunkle, JoAnn Orischak, Michael Rivers and Paul Roth were absent from the vote.

The Pledge of Allegiance was recited and Mrs. Cordray stated that the media was properly notified.

Public Comments

A community member expressed concern about the way that Board members handled the recent designation of make-up days related to instructional days lost due to Hurricane Matthew.

Approval of Calendars

The Board meeting calendar for 2017 was proposed. There was discussion on a variety of Board calendar issues, including the possible addition and improvement of community meetings aimed at gathering public feedback.

Mrs. Laura Bush made the motion to approve the Board Meeting 2017 Calendar. The motion was seconded by Mrs. Geri Kinton. The motion passed 10/0. Michael Rivers was absent from the vote.

Dr. Moss introduced proposed school academic calendars for 2017-18 and 2018-19. Dr. Moss said that the district would continue to urge the South Carolina General Assembly to give locally elected school boards more flexibility in determining academic calendars.

Student Services Report

Dr. Moss presented the Student Services report, which included data on student suspensions, disciplinary hearings, disciplinary infractions on school buses, the district's random drug-testing program, bullying prevention, homebound instruction and other topics. Dr. Moss gave an overview of the data in the report.

Retained Over-Age Children

Dr. Moss and Dr. Dereck Rhoads gave an overview of students who have been retained multiple times and, as a result, are older than students in their current grade levels. Dr. Rhoads also gave a briefed report on various ways that schools are addressing the issue.

Update on Source4Teachers

Ms. Alice Walton updated the Board on the district's first months of using a private-sector contractor, Source4Teachers, to coordinate the placement of substitute teachers in classrooms where the regular teacher is absent for some reason. To date, Source4Teachers is reporting a 76 percent fill rate compared to the 72 percent fill rate maintained by the school district when substitute placement was handled internally. Ms. Walton also presented the annual report from Human Resources that covered staff hiring, employee recruitment and retention, staff evaluations and other topics.

Update on Projects from Director of Innovation

Dr. Rhoads updated the Board on current projects being coordinated or contributed to by Director of Innovation Bonnie Almond, including Response to Intervention, alternative schools, the district ESOL program and Welcome Center, Title I schools, summer school for middle and high schools, Read 180 and the Military Child Education Coalition.

Capital Projects

Dr. Moss introduced the district's 10-Year Capital Plan, which was updated after the defeat of the one-penny education sales tax referendum on November 8. Dr. Moss told Board members that the needs intended to have been addressed by the sales tax referendum have not gone away. Carol Crutchfield, the district's Planning Coordinator, explained the basics of student assignments and enrollment growth projections. Facilities, Planning and Construction Officer Robert Oetting briefed the Board on school buildings across the district, energy usage at those facilities and expenditures on maintenance. Dr. Moss outlined potential options for funding the projects proposed in the 10-Year Capital Plan.

Meeting recessed at 3:02.

Day 2, November 19, 2016

Mrs. Mary Cordray reconvened the Board's two-day work session at 9:04 a.m.

Legislative Agenda

Mr. Drew Davis recapped the Board's 2016 legislative agenda before reviewing the South Carolina School Boards Association's Legislative Preview and then opening a discussion about a draft 2017 legislative agenda for the Board's consideration.

Items for consideration include increasing salaries for beginning teachers; revising the South Carolina Teacher Employment and Dismissal Act; supporting flexibility in state and federal school accountability systems; revising state law to allow a school district to create more than one school of choice within that district; increasing locally elected school boards' control of annual school calendars; and increasing funding for maintaining and replacing school buses.

Restructuring of Communications Office

Dr. Moss and Mr. Jim Foster briefed Board members on the restructuring of the school district's Office of Communications.

Proficiency Plan to Address All Courses

Dr. Moss and Dr. Rhoads briefed Board members on the concept of "proficiency-based" learning. The general goal of proficiency-based learning is to ensure that students acquire the knowledge and skills needed to succeed in school, higher education, careers and adult life. If students fail to meet expected learning standards, they receive additional instruction and support to help them achieve proficiency.

Board Feedback/Communications

Mr. Striebinger initiated a discussion about lessons learned regarding how the school district and the Board handled the process of determining how to make up instructional days lost because of Hurricane Matthew.

Before-School and After-School Programs

Dr. Moss briefed Board members on the current status of before-school and after-school programs offered at district schools. He added that the district would monitor the results of changes in school start times that were made for the current school year.

Mrs. Cordray adjourned the two-day work session at 1:22p.m.

Let's just say the petition succeeds in getting the 500 signatures Mr. Donelson was advised to obtain; that's only 5% of the entire student body! And if you comb through the signatures, many don't even live here or have any children attending BCSD schools. In my opinion, these signatures should be thrown out. So let's say it only has 300 valid signatures - so, 3%? Are the Board going to listen to (and god forbid cater to) the 3% who screams the loudest and disregard the opinions of remaining 93% of the student body?

To be perfectly honest, I am neither for nor against the earlier start time; I was raised in a culture that whatever changes made, we just suck it up: Improvise, Adapt and Overcome. I am writing to you regarding school start times. I will tell you that changing the high school and middle school times to the later time slot has changed our family life 100% for the better. I have 2 children and the two different start and end times were a nightmare. My children both play sports and the older they get the later they are getting home and still have homework to do. Elementary kids typically are in bed by 8-8:30pm and should have no issues getting up at 7am.

Once kids start to get to middle school age and above-they just are not going to be in bed with the lights out at an early time. My daughter who is 13 currently gets home from soccer at 8:45pm. An early release time will not help that issue and if anything having these older kids getting out at 2:30 doesn't really help. It gives them more time at home alone.

I will tell specifically how our life changed. In 6th grade my daughter had the 7:20AM start time. My daughter-in elementary was NEVER late one day. She won the "no tardy parties" every

year in elementary. She typically missed 2-3 days a year at most. Her 6th grade year she missed 12 days of school, she was tardy countless days for her first class. Almost every Monday (the entire year)half of her class was absent or would come in very late. My daughter is also a straight A, National Jr. Honor Society Student. This year, with the later start time: she does not have 1 tardy and has missed 1 day of school. The mornings are a dream, homework is getting done and both kids are getting the correct amount of sleep their bodies need. I feel it's kind of crazy that a group of elementary parents are trying to get this changed ONCE again. I mean their children are going to keep getting older and have to start back to this early time right when their kids are staying up later, going through puberty, playing travel sports. These age kids need their sleep more than any age group.

I hope you are having a pleasant afternoon. I thought I'd take a break in completing classified employee evaluations to send you a note about school start times as they relate to Red Cedar, particularly the staff there.

Some while ago, maybe six weeks ago, we put up two sheets of large paper in the workroom and asked staff, if they chose, to designate their preference of start times by signing their names to one or the other sheet. Nearly all staff members chose one or the other. Keeping us on the early time was preferred three to one over changing it back to elementary students starting and ending at the later time.

When we began this year, I was skeptical about the effects on younger children and their families of putting elementary schools on the early schedule, but I see some benefits. If bus delays are going to occur, they stack things up. Something that happens during the first round tends to stack things up going into the second round. Therefore, if your school is part of the first round, your chances of being delayed are lessened. It's nice to be the positive side of that after all of those years of it being the other way around. An unexpected plus, as mentioned by staff members who have elementary aged children (as well as some parents) is that there is now time after school for parents and children to play together in the neighborhood after school and still have time to get to a scheduled activity like soccer or dance.

Do we have more late arrivals to school? Yes, we do; about a 5 percent increase. We are pretty vigilant about keeping a dialogue going with those parents to help that improve. They are the same folks who were late to school last year, but now it's a bit more often, unless we can get them to really pay attention to it. I'm assuming on that score, however, that the tardy problem will rest more squarely with which ever level of school population has the "early shift," and at least for our school, I think we are more likely to push the issue with families to curtail it than high schools and middle schools.

Good luck making a decision on this; I hope you have all the information you need.

Please keep the 8:45 a.m. start time for Hilton Head Island high school and middle school.

The Hilton Head cluster has spent two years getting the traffic patterns and morning schedules settled and changing them yet again makes no sense. Additionally, older HS kids can drive their younger MS siblings to school, which helps cut down on the traffic and streamlines the morning drive.

The Hilton Head High School and Hilton Head Middle School start time of 8:45 a.m. should stay as it is. Please DO NOT change the start time to an earlier start. In the two years since the High School time changed to a later start and the year since the Middle School was added to that time,

I have seen tremendous success and change in the morning for both of my children.

The American Association of Pediatric Doctors has come out and clearly stated that starting after 8:30 a.m. is preferable for better academic performance for older kids. Regardless of the time they need to get up, older students will still stay up later doing homework. My children have AP, IB and Honors classes. Their course load is big. Without the later start of the past two years, they were constantly tired and not performing at their best. Now they are up more refreshed and ready to work because of the later start time, and both are in the top of their classes.

The elementary early start may be challenging, but for decades the older students have faced that challenge, and now medical evidence is being presented that shows older students do much better at a later start time. Younger kids do not have the same responsibilities or homework load that older kids do, and can get to sleep and up earlier with more success.
