Thank you for your request for public records in accordance with the South Carolina Freedom of Information Act. The BCSD does not anticipate the costs for associated with producing "repeated requests for reimbursements for the same items" will be reduced by your revised request. In order to determine which requests are repeat requests, the BCSD will need to review each reimbursement request to determine whether it is repetitive.

Additionally, the BCSD can retrieve and search Dr. Gwozdz's e-mail for specific search terms. The BCSD does not have the ability to search for "repeated requests" without pulling all e-mails and manually reviewing them.
