**Subject:** what is cab installers?

What is Cab Installers? I have attached a list of charges paid to a generic company or person called Cab Installers. There are numerous split payments made on the same day which is a violation of the Beaufort County School District Policy for its 51 Bank of America cards.

Was the Procurement Policy for these large expenditures followed? The attached charges were made on the Bank of America Procurement Card for this provider during the months of January 2017 through May of 2017.

The total for this time frame comes to **\$112,569.25.**

I have not bothered to do a FOIA request on this, since I have been told in the past for other requests that either this does not come under FOIA guidelines or that I have to pay an exorbitant amount for something that should be clarified in a Transparency Report.

This is just another example of the out of control use of the District's credit card. More oversight is needed by the Board and explanations are required by the person whose credit card was used.

I am asking for outside help at this point, since the majority of the School Board has shown no interest in doing its job as far as overseeing a \$230M annual budget which is more than the Beaufort County budget.

There needs to be an outside audit which would include all phases of the budget. The building and maintenance should be included in this audit as well as the Bank of America card use which annually totals \$30M.

This audit needs to be conducted by a firm which specializes in forensics, unlike the firm the District has used for many years.
