The BCSD will make the requested documents available to you in accordance with FOIA, subject to redaction of material exempted by S.C. Code Ann. 30-4-40. In accordance with S.C. Code Ann. 30-4-30(B), the BCSD estimates search, retrieval, and redaction, if necessary, of documents to respond to your request will require 129 hours, being an estimated cost of \$2,811.33, plus 6 cents per copy. Costs may increase or decrease. A 25% deposit of the total reasonably anticipated cost is required before work will begin on your request. Please make all checks out to the Beaufort County School District and send to my attention.

In response to your inquiry regarding "standards adopted by the Beaufort County School Board in regards to handling of FOIAs and specifically the waiver of all your fees", please refer to the Beaufort County School District FOIA Response Guidelines and Fee Schedule.
