We are interested in this on-going dialogue as it pertains to the TCL Foundation, Inc. Upon review of the most recent web-site advertisement for the 2017 *Swinging with Superintendent*, which appears to be primarily sponsored by Sodexo, it clearly states:

All proceeds.... are administered by TCL Foundation, Inc.

On the South Carolina Secretary of State's website, there is no record of the TCL Foundation, Inc. And, in fact, that name is available. Can you please provide us with the correct name of the corporation/foundation that has administered and, we assume, will continue to administer, all proceeds for the *Swinging with the Superintendent* event? Please accept this email as a formal FOIA request for the following documents as they pertain to your self-created event:

1. The 501(c) IRS and SCDOR exemption status Certificate.
2. By-Laws, Amendments, and Resolutions, especially concerning the approvals of the initial creation of your event and their participation, and the subsequent sequels to the same; expenditures and budgets.

3. A list of all Board Members, with their contact information.
4. Copies of any and all 990's for the time period of 2014 to present as they pertain to the *Swinging with the Superintendent events*.
5. Copies of any and all Agreements between the you and/or the Beaufort County School District and/or Beaufort County Board of Education and TCL and any and all vendors as to their respective responsibilities associated with the *Swinging with the Superintendent* event(s).
6. Copies of any and all Agreements between the Beaufort County School District, the TCL Foundation, Inc., and all vendors, as it applies to the responsibilities of each in the marketing, advertising, collection and distribution of any and all proceeds related to the *Swinging with the Superintendent* event(s).
7. A copy of your business and budget plan you and/or anyone on your behalf originally submitted to this Foundation for the approval of said self-benefiting Tournament.
8. Copies of the Budgets for each and every year submitted and approved prior to said events.
9. Copies of Financial Audits of these events.
10. Ledger sheets detailing any and all collected proceeds and disbursements regarding any and all funds or in-kind donations associated with these the *Swinging with the Superintendent* event(s)

Finally, you are quoted on the *Swinging with the Superintendent* web-site advertisement thus:

What a fun way for the community to come together to support our students as they continue on a path of learning

What a grand sentiment for those who golf and can afford the equipment to participate in a sport you obviously enjoy. Tell us of any other *fun* community activities you have created to even the playing field for parents and citizens who do not golf, have no desire to golf, yet would like the same opportunity to come together to support our students (other than chapping your hide about your spending habits)?

We will expect all of these documents in the ten (10) business days required by law. We also ask you exercise your authority pursuant to Beaufort County School District guidelines and waive the costs of responding to our FOIA as it is most definitely in the public interest.
