Additionally, most if not all of the data you are requesting would be exempt from release because it is not a permissible use pursuant to The Fair Credit Reporting Act (FCRA), 15 U.S.C. §1681-1681y, it is information of a personal nature where the public disclosure of such constitutes an unreasonable invasion of personal privacy pursuant to S.C. Code Ann. 30-4-40(a)(2), and per The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99).
