Please consider this a request under the South Carolina Freedom for Information Act.

This request includes the following records:

An electronic copy of end-of-the-year reports for the 2013-14, 2014-15, 2015-16, 2016-17 and 2018-19 school years created by the three law enforcement agencies that provide school resource officers to the Beaufort County School District.

In talking to Alfredo Givens, SRO supervisor for the Beaufort Co. Sheriff's Office, I understand that a report is created by his department each year that breaks down the number of police reports generated at each school by the nature of the alleged crime (ex: assault/battery, drugs, etc.)

My impression is that your agency would also have a version of this report from the Beaufort and Bluffton police departments for the schools in which they provide school resource officers for.

If your agency has something close to, but not exactly what I am seeking, please feel free to let me know. I am not asking your agency to create a new record, but rather provide me with any such electronic record you keep that would be responsive to this request.

As a member of the news media seeking this information in the public interest, I respectfully request fees be waved, per statute. If charges are necessary for this request, please provide me with a detailed breakdown of the anticipated charges before fulfilling the request.
