I contacted Instructional Services and they have indicated that federal law mandates that we maintain a database to report the data, not that we have to annually pull the data. This request will take 2 days to complete. The timeline for completion is due to the way older versions of PowerSchool handled the duration or length of a suspension. Older versions of PowerSchool did not have a field for hours, the newer version does and makes for more work to compute hours to days. The estimated cost is \$520.48. Costs may increase or decrease. An electronic record or records, such as an excel spreadsheets, that detail the number of school days missed due to out-of-school suspensions, , broken down by race and gender, at each school in the Beaufort County School District for the 2013-14, 2014-15, 2015-16, 2016-17 and 2017-18 school years. I am also requesting the total enrollment numbers at each school in the district broken down by race and gender for each of those school years.
