**This Addendum Number Nine** dated as of June 11, 2019, is entered into pursuant to the Contract between Beaufort County School District, hereinafter “BCSD”, and GCA Education Services, Inc., hereinafter “Contractor”, dated July 1, 2014.

**Now, therefore**, in consideration of the mutual covenants and promises and for other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the parties hereto agree as follows:

**Whereas**, Section III allows BCSD the option to extend the five-year term upon approval of the BCSD Superintendent. The Agreement is extended for one (1) year for the period July 1, 2019 through June 30, 2020, and

**Whereas**, Section IV allows for adjustments to Contract Compensation to reflect increases in the United States Department of Labor, Bureau of Labor Statics, Consumer Price Index (CPI) for All Urban Consumers, All Items, South Area,

1. The Contract Compensation shall be increased by the Consumer Price Index change from April 2018 to April 2019 (1.80% CPI increase) applied as follows:

BCSD Contract Compensation on June 30, 2019	\$ 3,411,580.00
Multiplied by CPI increase of 1.80%	<u>          x 1.80%</u>
BCSD CPI increase in dollars	\$ 61,408.00
BCSD Contract Compensation on July 1, 2019	\$ 3,472,988.00
ACE Contract Compensation on June 30, 2019	\$ 22,812.00
Multiplied by CPI increase of 1.80%	<u>          x 1.80%</u>
ACE CPI increase in dollars	\$ 411.00
ACE Contract Compensation on July 1, 2019	\$ 23,223.00

2. BCSD Contract Compensation shall be payable in twelve (12) equal monthly amounts of \$289,416.00. ACE Contract Compensation shall be payable in twelve (12) equal monthly amounts of \$1,935.00.

All other terms and provisions of the Contract dated July 1, 2014, as amended, shall remain in full force and affect.
