**This Addendum Number Six** dated as of July 1, 2017, is entered into pursuant to the Contract between Beaufort County School District, hereinafter “BCSD”, and GCA Education Services, Inc., hereinafter “Contractor”, dated July 1, 2014.

**Now, therefore**, in consideration of the mutual covenants and promises and for other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the parties hereto agree as follows:

**Whereas**, Section III allows BCSD the option to renew the Agreement for two (2) one (1) year terms. The Agreement is extended for one (1) year for the period July 1, 2017 through June 30, 2018, and

**Whereas**, Section IV allows for adjustments to Contract Compensation to reflect increases in the United States Department of Labor, Bureau of Labor Statics, Consumer Price Index (CPI) for All Urban Consumers, All Items, South Area,

1. The Contract Compensation shall be increased by the Consumer Price Index change from the base year six-month average July through December 2013 to the six-month average July through December 2016 (less the 1.48% CPI increase of 2015) of One and Thirty-Five One Hundredths (1.35%) percent applied as follows:

2. The retirement of a BCSD employee necessitated the replacement of one (1) painter position with a GCA employee. The replacement painter will result in an annual increase in GCA pricing of \$42,598.00.

3. BCSD Contract Compensation shall be payable in twelve (12) equal monthly amounts of \$274,628.00. ACE Contract Compensation shall be payable in twelve (12) equal monthly amounts of \$1,864.00.

All other terms and provisions of the Contract dated July 1, 2014, as amended, shall remain in full force and affect.


